Please contact RGLTracking@RGLLogistics.com with any tracking updates or concerns. All loads over 150 miles must be tracked via Trucker tools for GPS tracking. If you cannot or will not comply, please advise at time of load acceptance for discussion. We do ask all carriers to do their best to comply and provide driver's first name and ph number for tracking. If it is not supplied, you run the risk of having the load taken back. You will not be paid a TONU if we remove you from the load due to lack of driver info or updates. There may also be a \$150 penalty for not accepting tracking before PU applied or if tracking is shut off by driver in transit. Tracking is mandatory unless otherwise discussed.

If you experience detention, we need to be updated immediately before the 2 hrs of free time lapses and the times for the site need to be noted on the BOL/POD and forwarded to us within 24 hrs of occurrence of the PU and DL time noted on rate confirmation to be approved.

- 3. All pickup and delivery delays shall be reported to RGL immediately at rgltracking@rgllogistics.com.
- 4. Carrier shall look only to RGL and not to involve the shipper, consignee or customer of RGL for payment of Carrier's freight charges under this agreement.
- 5. All claims must be resolved within 30 days. RGL reserves the right to deduct the amount of a claim from Carrier's freight charges.
- 6. By signing below the Carrier warrants that it is duly and legally qualified to provide the transportation services contemplated herein, and that it holds liability insurance of at least \$1,000,000 and cargo insurance of at least \$100,000
- 7. Carrier must provide a signed BOL to receive payment. Payment is made within 30 days of receipt of paperwork. Preferred email is billing@rglspecialty.com.
- 8. Double brokering is prohibited. If Carrier re-brokers or double brokers the load Carrier's freight payment is null and void, and they may owe damages to RGL.
- 9. Lumper receipts must be received within 24 hours for reimbursement.


