Rate Confirmation Agreement for TCI Global Logistics

- All Shipments require freight visibility tool tracking, i.e., Macro Point, TruckerTools or Four
 Kites are subject to a \$50 daily penalty, if no tracking is performed. If a driver is unable to track,
 this information must be provided prior to loading.
- Detention time starts 2 hours after the driver is on site, starting from the appointment time
 listed on this rate confirmation. Detention is paid at \$35 per hour after the 2 free hours.
 Detention and layovers are only approved if load is actively tracking during detention or
 layover. To receive detention payment, TCI Global Logistics must be notified 30 minutes prior to
 entering detention, to assist in avoiding these costs.
- Seals may only be broken by shipper or receiver or with written authorization from TCI-Global Logistics. Loads delivered without the seals intact will result in fines and potential claims.
- Any authorized unloading will only be reimbursed with a valid unloading receipt.
- If the load/shipment is double brokered, this agreement is void and the carrier will not receive payment. All drivers operating as an employee, for hire, owner operator, and/or lease operator for CARRIER on a load tendered by BROKER must have an officially issued DOT sticker on the door of the vehicle operating the load that matches CARRIER DOT authority number with the company being tendered the load by BROKER, failure to comply, the carrier can forfeit all rights to payment on this load by BROKER and its customers.

TQL must approve all accessorial terms/charges in advance and in writing. Payment of detention is determined on a load-by-load basis. Unauthorized charges will not be paid. Detention payment does not begin for at least 3 hours unless otherwise agreed to in writing. To qualify for additional compensation, the Carrier MUST notify TQL at least 30 minutes before beginning detention time and when arriving-on-time/departing from all shippers/receivers (unless the shipper/receiver will notate check in/out times on the paperwork).



THIS IS AN AGREEMENT BETWEEN TQL AND CARRIER. CARRIER SHALL HAUL THE LOAD AT THE RATE ABOVE. CARRIER SHALL CALL TQL FOR LOAD INFORMATION. IF LOAD IS CHANGED OR CANCELED BY TQL, NO "TRUCK ORDER NOT USED" WILL BE PAID UNLESS TQL HAS PROVIDED THE CARRIER WITH LOAD DETAILS (PICK-UP NUMBER, SHIPPER NAME/ADDRESS AND DRIVER INFORMATION SHEET) AND APPROVED THE CARRIER TO BEGIN DRIVING TOWARDS THE PICK-UP LOCATION. THE SAFE, LEGAL AND PROPER OPERATION OF CARRIER SUPERSEDES ANY REQUEST, DEMAND, PREFERENCE, INSTRUCTION OR INFORMATION PROVIDED BY TQL OR ITS CUSTOMERS WITH RESPECT TO ANY SHIPMENT. IF ANY EMPLOYEE OF TQL OR ITS CUSTOMER REQUESTS, DEMANDS, OR INSTRUCTS CARRIER TO TAKE ANY ACTION THAT VIOLATES ANY LAW, CARRIER SHALL REFUSE TO TRANSPORT THE LOAD AND IMMEDIATELY CONTACT TQL BEFORE TAKING ANY FURTHER ACTION. CARRIER AGREES THAT WHEN IT CHOOSES TO TRANSPORT A LOAD IT DOES SO ON ITS OWN VOLITION, EXERCISING ITS OWN DISCRETION WITHOUT COERCION OR UNDUE INFLUENCE BY ANY INDIVIDUAL OR ENTITY. **CARRIER OR ITS AGENT CERTIFIES THAT ANY TRU EQUIPMENT FURNISHED WILL BE IN COMPLIANCE WITH INUSE REQUIREMENTS OF CALIFORNIA'S TRU REGULATIONS.

THIS AGREEMENT IS SUBJECT TO THE TERMS OF THE BROKER/CARRIER AGREEMENT SIGNED BY THE CARRIER AND TQL. THIS AGREEMENT IS AN ADDENDUM TO THE BROKER/ CARRIER AGREEMENT. THIS RATE CONFIRMATION IS INCLUSIVE OF ALL CHARGES.

IF THIS SHIPMENT RELATES TO A GOVERNMENT OR QUASI-GOVERNMENT CONTRACT (WHICH MAY INCLUDE, WITHOUT LIMITATION, FEDERAL, STATE, MUNICIPAL, OR POSTAL CONTRACTS), THEN THE SHIPMENT IS SUBJECT TO THE NOTICES AND COMPLIANCE REQUIREMENTS FOUND AT HTTPS://www.tql.com/government-contractor-notices.pdf or a hard copy will be provided upon written request to compliance@tql.com.

THE CARRIER, DRIVER, AND ANY OTHER EMPLOYEE AND/OR AGENT FOR CARRIER ASSUME ALL RESPONSIBILITY FOR ABIDING BY THESE INSTRUCTIONS AND AGREE THAT THEY WILL COMPLY WITH ALL APPLICABLE FEDERAL, STATE AND LOCAL LAWS INCLUDING, BUT NOT LIMITED TO: RECEIVING, READING AND/OR SENDING SMS MESSAGES, PHONE CALLS, AND/OR ANY OTHER INFORMATION TO OR FROM THE BROKER. CARRIER AGREES TO INDEMNIFY AND HOLD TQL HARMLESS TO THE FULLEST EXTENT PERMITTED BY LAW FOR ANY AND ALL CLAIMS OF ANY NATURE ARISING OUT OF OR RELATING TO THE HAULING OF THIS LOAD, THE VIOLATION OF THE TERMS OF THE BROKER-CARRIER AGREEMENT OR THIS RATE CONFIRMATION.





Driver must accept TQL's Carrier Dashboard tracking or MacroPoint tracking. Tracking must be maintained for the entirety of transport.

Carrier must be able to provide reefer calibration records and reefer download within 24 hours upon request.

Trailer Requirements:

- Trailer must be sealed at time of loading prior to leaving the shipping facility.
- Trailer must be padlocked while in transit in addition to the seal.
- Trailer must be in good, safe, and lawful operating condition at all times.
- Trailer must be clean, odor-free, dry, leak free, and free of contamination and infestation.
- Trailer may be subject to inspection by the shipper to determine if it meets the shipper's standards.
- Trailer must not have ever been used to transport any of the following commodities:
 - Poison
 - Refuse
 - Garbage
 - Trash
 - Solid or Liquid Waste of Any Kind (Hazardous or Non-Hazardous)
- Trailer may be subject to a "back strip" search while at the shipper or receiver. This may involve off-loading the trailer and checking products against all the shipping documents.
- In the event of a "back strip" search, driver must fully cooperate if their load is chosen at random, and there will be no advance notice given in most situations.

Shipment Requirements:

- · If the trailer is dropped early for delivery, the trailer must be dropped in a secured fenced lot.
- If the trailer is dropped in an unsecured lot, the trailer must be secured with a padlock and a king pin lock.
- · If the seal has been broken, the trailer must be returned to the shipper free astray and may be subject to a claim.
- If there is an issue with the reefer trailer, calibration records and calibration information must be provided to TQL
- Driver must accept TQL's Carrier Dashboard/Macropoint Tracking
- Exclusive use of the trailer is required, and the load cannot be run as a partial
- Load cannot go to the driver's home or be left unattended
- Driver(s) must arrive at the shipper with a full tank of fuel, well rested, and fresh on hours
- Driver(s) must drive 250 miles after picking up
- Trailer must be locked and sealed prior to leaving the shipper
- Driver(s) must back up against a wall or pole to ensure the doors cannot be opened any time a stop is to be made, and one driver
 must maintain line of sight with the trailer doors at all times

Detention:

- · 2 hours free.
- \$50 per hour after free time.
- Charges will be paid in 15-minute increments
- \$450 max for 24-hour period
- · Detention must be billed with written signed confirmation of arrival and departure times by either shipping or receiving location

Layover:

- \$200 overnight
- \$600 weekend

Loading/Unloading:

\$100 per trailer OR actual lumper cost, whichever is greater. Lumper receipts must be included with billing invoice
