This process is to protect the carrier from being charged any restacking fees.

*****Congo Beverage loads require GPS Tracking***.** MacroPoint is available through Sage Freight if needed. GPS will be required to document any detention claims or deflect \$250.00 late deliveries fees caused by shipper delays. Detention must be report to Congo Beverage in real time for it to be approved. Congo wants this real time

notification to push the shipper to reduce detention.

Truck Ordered Not Used: Congo pays \$150 per load for FTL and \$100 for box truck loads.

Carriers must be CTPAT Certified for all Canadian loads. Sage Freight is not responsible for any charges incurred due to border inspections.




