- 6. Carrier agrees to wear all Personal-Protective Equipment (P.P.E) during pick up and delivery. Failure to do so may result in a \$250 fine to the carrier via rate reduction.

- 10. Submit Invoice, Notice of Assignment (if you are working with a Factoring Company) and Proof of Delivery, to our email within 72hrs of delivery or you will be fined \$150.00. After the seventh day an extra \$50 per day will be charged as a late fee. Sending just the BOL does not exempt from the fine. Make sure you send it to: ap@unicronlogistics.com Fax# 702-852-0889 Ext 3. If invoice is not received 45 days after delivery, payment to the carrier is null and void.
