*Rate shown includes any applicable fuel surcharges, pickup and delivery charges, loading and unloading, out of route, detention, storage, and/or all arbitrary charges etc. Deviation from these rates must be approved in writing and signed by both parties.

*Any authorized unloading will only be reimbursed with a valid unloading receipt.

*Check calls must be made daily by 9 am EST or carrier will be charged a penalty fee of \$200 per day.

*If pickup or delivery times are missed without prior notification to Entourage Freight Solutions, carrier will be subject to penalty charges of \$200 per day. Additional late delivery charges assessed by the consignee may also apply,

"In order to collect detention carrier must notify Entourage Freight Solutions within 2 hours after appointment time of any delays. Late pick-ups or late deliveries are not eligible for detention charges, If facility is FCFS, detention will only be paid if carrier is loaded or unloaded outside of the regular pick-up or delivery hours.
