 take 5 to 10 business days to process. All additional charges (outside of what was agreed to at time of load booking) must be
 requested, via email, within 2 business days of delivery. If Gampac or carrier issues payment for an ancillary fee at shipper or
 receiver (pallets, unloading fees, etc.) the receipt must be submitted within 2 business days, or Gampac reserves the right to decline
 reimbursement.
- Carrier will not re-broker, co-broker, subcontract, assign, interline, or transfer the transportation of shipments hereunder to another person or entity conducting business under a different operating authority, without prior written consent of Gampac. If carrier breaches this provision, Gampac shall have the right to pay the monies it owes carrier directly to the delivering carrier, in lieu of payment to carrier.
