LUMPER REQUEST

Convenience fees/services charges on lumpers are non-refundable.

Photos of pallets MUST be provided for any additional charges on lumper receipts for restacking, receiver allows drivers on dock

Lumper receipts must be submitted within 24 hours of delivery or risk reimbursement.
