# **Terms and Conditions**

The Broker-Carrier Agreement or Carrier Agreement (in each case, the "Agreement") between Coyote Logistics, LLC, a Licensed Property Broker - USDOT # 2236410, and Zigi Freight Inc is amended by the verbal agreement between Jared Soderholm of Coyote Logistics, LLC hereafter referred to as BROKER, and Robert Jovanovic of Zigi Freight Inc hereafter referred to as CARRIER, dated 04/11/2024.

This confirmation is subject to the terms of the Agreement and this document constitutes an amendment thereto. If the CARRIER has not signed the Agreement, then the rate shown above is the agreed individually negotiated rate and no other rate shall apply including any carrier tariff rate or terms.

THIS LOAD SHALL NOT BE DOUBLE BROKERED. No additional charges not listed above may be added by the CARRIER. Any additional charges must appear on a revised confirmation sheet signed by the BROKER. CARRIER must include signed copy of the shipper's bill of lading and any other proof of delivery with invoice to BROKER. Rates, except as specifically designated above, are inclusive of any fuel surcharge. CARRIER certifies that it is in compliance with all requirements of the California Air Resources Board (CARB) that are applicable to the scope of CARRIER's operations, including, but not limited to: Statewide Truck and Bus Regulations, Transport Refrigeration Unit (TRU) Regulations, Tractor-Trailer Greenhouse (GHG) Gas Regulations, and Drayage Truck Regulations. CARRIER also warrants that it is in compliance with any comparable requirements of the Environmental Protection Agency (EPA) and other states, where applicable. CARRIER shall be responsible for any fines imposed on BROKER and/or shipper resulting from noncompliance.

CARRIER hereby confirms that it maintains applicable and valid insurance without exclusions that would prevent coverage for the items listed above. CARRIER has at least \$100,000.00 in cargo insurance and \$1,000,000.00 in automobile liability coverage. # **Construction Delivery Traffic – Driver Requirements and Driving Instructions**

Drivers MUST wear proper PPE as listed below.

Drivers providing construction material delivery service must carry and abide by these instructions.

#### 1. DELIVERY APPOINTMENTS REQUIRED:

All construction delivery traffic <u>will be required</u> to schedule with the Logistics Coordinator or Superintendent prior to shipping any material to the Wolf Run site. Please notify (2) days in advance of arrival either via phone or email.

#### 2. DELIVERY REQUIREMENTS:

LAYDOWN yard entrance (see Transportation Map on page 3).

- Look for signs labeled **Wolf Run Deliveries**. Entrance on Baseline Rd.
- Construction truck traffic shall not arrive at the project entrance prior to 7:30 a.m. or more than 30 minutes prior to their scheduled appointment time.
- All drivers <u>MUST</u> check in with security or site personnel upon arrival on site.
- Delivery truck drivers will stand by until Logistics is contacted and is available to escort the truck (if needed to desired location for off-loading).
- If there is a storm and lightning stand down is called, please **STAY** in your truck until **ALL CLEAR** is called out.
- Trucks may **NOT** enter the site road after hours.

### 4. DELIVERY HOURS:

Site delivery times are from 7:00 a.m. until 2:00 p.m. CST (Final Appointment).

- By appointment only Monday thru Friday. (Time in and out may change due to Daylight Savings Time). Itis\_ NOT a first come first serve.
- Calls will be answered from 7:00 a.m. till 4:00 p.m. CST Monday thru Friday only.
- A delivery date and time will be provided by Signal's Logistics Coordinator or Superintendent and given to your logistics personnel prior to delivery.
- If you show up without a scheduled appointment and/or BOL, you will NOT be offloaded.

#### 5. UNLOADING SCHEDULE:

- Free time for unloading shall not be less than two (2) hours and shall begin at their scheduled appointment time.
- No detention charges shall accrue for time waiting due to missing a scheduled delivery time.
- Deliveries not scheduled through Logistics Coordinator or Superintendent may be turned away or be required to wait for next available delivery slot.

## 6. REQUIREMENTS: PLEASE READ CAREFULLY

- All drivers must wear **Personal Protective Equipment (PPE)** while on the Wolf Run Solar site.
  - This includes:
    - ✓ Steel toe or composite safety boots or shoes
    - ✓ Hard hat w/safety glasses
    - ✓ Reflective safety vest or similar reflective coat/jacket
    - ✓ Long pants / Shirt with 4" minimum sleeves
    - ✓ Gloves (if handling or working with material)
- All passengers must remain in their vehicle. Absolutely no pets are allowed outside of vehicle.
- Leave all loads secure and strapped until directed to remove them.
- NO REFER Trailers. Only Dry Vans, Containers and Flat Beds.
- Must have all proper paperwork/BOLs in hand not electronic copies and a prior scheduled appointment date and time.
- <u>Speed Limit</u> Drivers are to travel at a maximum speed of 10 mph while traveling on the job site or speed indicated on posted signs. Note: if you are causing dust please slow down and while passing the workers - 5 mph.
- Trucks are prohibited from parking overnight onsite (please look for local truck stops in the area).
- <u>Cell phone operation</u> Absolutely no cell phone operation, verbal or text, is permitted while operating vehicles on site.
- Seat belts All drivers are required to wear seat belts while operating vehicles on site.
- <u>Trash</u> Signal Energy has very strict trash removal requirements for protection of wildlife. All trash, including biodegradable material such as food waste, must be properly disposed of in a covered trash receptacle or taken out from site.
- <u>Penalties</u> Drivers and Shippers must adhere to the Rules and Regulations of the project site. This includes but is not limited to site delivery times, speed limits and PPE.
  - ✓ Failure to follow site rules can lead to refusal of load and driver banned from sites.

- Report all vehicle incidents or injuries to Signal Energy personal immediately on or off the site.




# TRANSPORTATION MAP
