Special Instructions:

- Macropoint tracking is mandatory. The driver needs to accept tracking 2 hours prior to the pickup time and maintain tracking until the load is delivered.
Failure to comply will result in a \$150.00 rate deduction.
 - The carrier needs to inspect the product and report any damages or shortages at the time of pickup. Failure to report will result in additional charges.
 - The freight needs to be secured with at least 2 load bars or 2 load straps. It is the driver's responsibility to ensure that the load is safe, secure and legal for transport.
Once loaded, carrier needs to send time in and time out, photos of secured freight, seal and BOL in order to depart the shipper.
Once unloaded, the carrier needs to send the POD with a receiver's signature in order to depart the receiver.
 - Upon delivery, carrier needs to send the POD within 24 hours
 - Arriving late to the pickup appointment will result in a \$150.00 rate deduction.
 - Arriving late to the delivery appointment will result in a \$150.00 rate deduction.
 - All trailers must be odorless, clean, without any holes or leaks. They need to meet all regulations per FSMA act.
 - All reefers must be odorless, clean, without any holes or leaks, chutes intact and free of rips in good working order. They need to meet all regulations per FSMA act.
 - If the shipper rejects the unit, a TONU will not be issued.
 - Any deviation from agreed dispatch instructions must be called in immediately.
- Request for detention must follow the policy listed: The carrier needs to notify appropriate Unico staff after 2 hours from arrival and every hour thereafter until loading / unloading is complete.
- ABSOLUTELY NO DOUBLE-BROKERING OR CO-BROKERING - It is agreed that any re-brokering of this load will result in non-payment to the carrier, in addition to any other penalties applicable by contract or by law.
