IMPORTANT INFORMATION

All FTL Carriers must track loads using Macro Point unless a different tracking tool is approved by Boomer Logistics.

Each day a load fails to track via Boomer Logistics approved tracking tools, will result in a \$50 per day fee

Carriers can NOT double broker loads. If a carrier double brokers a load, Boomer Logistics has the right to withhold payments and will withhold payments owed to the carrier.

The BOL(s) must be sent to the Boomer Logistics dispatcher directly after loading . A \$50/day fee will be applied each day the BOL is not delivered. The dispatchers contact information (including email) can be found on the tender.

A \$250 late fee will be applied to trucks that miss their delivery time by more than 1 hour and 55 minutes with no advance notice.

If team load is booked, we expect two drivers running at a team pace (1,000+ Miles per 24 hours).

All reefer loads must be set on continuous setting for duration of load (No Exceptions). All Temp settings will be documented on the load tender.

If an issue with a load occurs during pick up or delivery, the Driver/dispatcher must inform Boomer Logistics and wait for approval before moving the truck

The driver is responsible to ensure all pickups are complete and that pick-up numbers & quantities match the tender.

Seal on trailer must be intact upon delivery. If seal is to be broken for any reason, you MUST inform your dispatcher and receive approval from Boomer Logistics before doing so.

Carriers are expected to make deliveries on time. Failure to make on-time deliveries without notice will result in a deduction of pay at the discretion of the customer.

Failure to communicate delays in a timely manner will result in a deduction in pay. If an emergency occurs, please email dispatch@boomerlogistics.com and someone will respond back in a timely manner."

If a claim happens on a load, Boomer Logistics has the right to withhold payments and will withhold payments for the current load, and withhold payments associated to other loads you have with Boomer Logistics to off-set the claim.

Failure to do comply with these terms will result in a deduction against the total payment.

PAYMENT INFORMATION

Carriers MUST send invoices & BOL to accounting@boomerlogistics.com for payments to be processed. Invoices will NOT be processed without Boomer Logistics receiving the Bill of Lading (This includes carriers approved for Quick Pay)

All loads will be paid in 30 days unless a Quick Pay option is requested and approved by Boomer Logistics

24 HOUR QUICK PAY FEE IS 3.0% OF THE PAY RATE

If a carrier breaks any of the rules noted in this document (including but not limited to tracking on macro point, solo drivers on team loads, short product, damages, late pick-up/delivery, temperature issues and or delayed BOL's) they will NOT qualify for quick pay.

The invoice must state the Boomer Logistics load # and preferred method of payment.

WE OFFER 3 QUICK PAY OPTIONS

- 1. Check by Mail: check by regular mail Will be processed within 24 hours.
- 2. T-Check: T-Checks will be issued in \$1000 increments with a fee of \$10 per T-Check. They will be processed within 24 hours.
- 3. ACH/EFT: This will be processed 48 hours after receipt of invoice & BOL (\$35 ACH fee will apply)

FUEL ADVANCES (processed by T-Check)

Boomer Logistics offers up to 40% of the total rate for fuel advances to all carriers once the load is picked up and the BOL has been submitted to the Boomer Logistics Dispatcher.

A 3.0 % charge will be applied on the total rate plus a \$10.00 fee per T-Check.

FACTORED INVOICES
