### **Equipment Requirements:**

Trailers must be empty, clean, in sound physical condition, odor free, dry, leak proof, and free of contamination/infestation.





- Trailer height must be AT LEAST 98" for door and trailer
- Trailer width must be AT LEAST 102" for door and trailer
- No TONU will be paid for rejected trailers
- · Carrier must be able to scale weight listed on rate confirmation; no TONU will be paid to carriers rejected due to weight issues
- Load locks or straps required for load securement
- Carrier must confirm they have the necessary equipment to safely secure the load without damage such as straps, chains, dunnage, braces. Any damages caused by improperly securing load may be claimed.
- Trailer manufacture date must NOT be older than 8 years from the date of loading.
- If trailer is rejected due to the age of trailer then deadhead mileage, detention, layover or TONU will not be provided or paid.
- In the event of a weight issue, empty/before loading scale tickets and loaded scale tickets to determine true weight are required.
- In the event shipment is legally overweight, compensation will be limited to \$0.05 per pound.

### **Tracking Requirements:**

- Driver must accept and maintain TQL's Carrier Dashboard/Macropoint/Project44 tracking for the duration of the shipment.
- Failure to accept and maintain TQL's tracking request for the duration of shipment will result in denial of any accessorial pay.
- Failure to accept TQL tracking may result in removal from load, no TONU will be paid to carriers removed from load for failing to accept TQL's tracking request.
- If tracking is not accepted and/or does not remain active for the duration of shipment, a fee of \$150 may be claimed and deducted from the agreed upon pay of the shipment.

### Carrier Requirements:

- · Carrier is responsible for securing, maintaining, and paying for any permits necessary to haul this load
- Driver(s) must be checked in on time for scheduled loading/unloading appointment/within FCFS loading/unloading window in order to be eligible for any accessorial pay.
- Please note that some shipping or receiving locations may require you to have a reflective vest, steel toe boots and a mask covering

- Failure to call TQL if/when loaded with the incorrect PO may result in non-payment of the load, a claim, or repower.
- This is a trailer inspection report that the customer uses to check all trailers that we send to them. I would like to ensure all carriers have a copy of this prior to them heading to the shipper to prevent rejection issues.
- Late pick up or delivery may result in non-payment of freight charges, and special damages as a consequence of being late may
  apply. This includes, but is not limited to, freight charges for expedited shipments, packaging materials, additional labor charges,
  storage charges, spoiled product, loss of sale, the expense of any additional equipment, service, or alternate transportation
  arrangements that need to be utilized as a result of late pick up or delivery.

### **Border Crossing Shipment Requirements:**

- Carrier must submit information for border crossings 24 hours in advance of border crossing attempt. Required information will
  include but is not limited to: PARS/PAPS number, Port of Entry and estimated time of crossing must be submitted.
- Failing to provide the necessary information to TQL may cause a delay in the customs clearance of the load and layover/detention/wait time will not be compensated for the first 24 hours of information having been received.
- All information must be relayed to TQL in writing; verbal advisement must be followed up with written documentation.
- Carrier must immediately report issues regarding customs clearances by sending an email to Akincaid@tql.com
- If a customs clearance issue is reported on a Saturday or Sunday, layover/detention/wait time will begin at 9:00am the following Monday.
- Any layover/detention/wait time at the border will be calculated based on when the email alerting TQL of the issue is received.

### Loads Attended & Recovered:

- The driver of the load is not permitted to leave the cargo unattended at any time. Cargo left unattended by the driver, regardless of whether it is left at a secured lot, warehouse, plant or parking lot is strictly forbidden.
- In the event of an emergency TQL must be notified as soon as it is safe to do so, and before the load may be left unattended.
- In the event of a breakdown or any delay that jeopardizes on time delivery, TQL may request that the carrier allow a repower of their trailer to avoid/mitigate damages.
