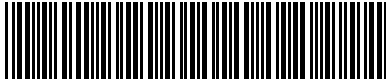

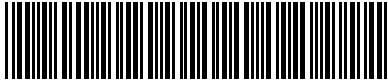

BOL / POD must be signed with the delivery date, time, legible printed name, and signature or stamp of the receiver. BOL / POD must be sent to Stellantis@rxo.com and SHTracking@rxo.com within 24 hours of delivery. Failure on any of these requirements will result in a \$250 fine. RXO reserves the right to deduct an extra \$250 for each day after that the BOL / POD is not provided.

Email stellantis@rxo.com and SHTracking@rxo.com prior to anything that may result in extra costs and / or additional accessorial charges. Examples include - driver assist, stop off, detention about to start, layover, etc.

By accepting this load, you are agreeing to pick-up and deliver a Stellantis / Fiat-Chrysler EXPEDITE AUTOMOTIVE load. Failure to deliver at or before the delivery time provided on this rate-con will result in a plant / assembly line shutdown that could cost over \$100,000 in damages. Please treat this load accordingly.

If for any reason driver will not be able to deliver at or before the delivery time provided on this ratecon, please notify Stellantis@rxo.com and SHTracking@rxo.com immediately. Failure to do so will result in a \$500 fine.

If any delay occurs that could possibly cause driver to not be able to deliver at or before the delivery time stated on this rate confirmation, the load should be re-powered with a new driver and/or new power unit immediately. If unable to repower internally, please email stellantis@rxo.com and we will work to recover / repower with a different carrier. Please expect a trailer interchange agreement to be sent over.

BOL must be emailed to Stellantis@rxo.com and SHTracking@rxo.com before driver departs from shipper. Failure to do so will result in a \$250 fine.

If carrier is found to be utilizing a solo driver on a load designated to require team drivers, carrier is eligible to be fined up to the total amount of the rate for completing the load.

If for any reason driver will not be able to pick-up at or before the time provided on this rate confirmation, please notify Stellantis@rxo.com and SHTracking@rxo.com immediately. Failure to do so will result in immediate termination from RXO carrier base.

The delivery time specified on this rate confirmation is the latest possible time that this load can deliver. All efforts should be made to deliver load directly or earlier.

Loads must auto-track via Macropoint or ELD with truck / trailer integration. If for some reason these can not be executed, a live tracking link must be provided upon request.

By taking this load, dispatch and drivers agree to constant communication via email or phone with RXO Logistics. If RXO is unable to reach either driver or dispatch in any way after initial attempt, carrier will be subject to \$250 fine after 1 hour. The carrier will be fined \$250 for each hour beyond this where RXO is unable to communicate with carrier.

If an inaccurate trailer number is provided, the carrier forfeits any claim to detention, layovers, or any accessorial where they may receive compensation. To avoid this, the carrier must provide the corrected trailer number before the load is picked up, and carrier must receive explicit written confirmation from RXO Logistics that the corrected trailer number has been received. If the carrier does not execute this correction before the load is picked up, no additional compensation will be administered.

The reference number for pick-up and delivery will be the CG 6-digit number on the second page of your rate confirmation. This number is called the AETC number.

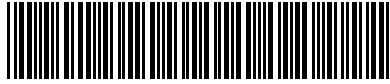
