<1> Proof of Deliveries:

<2> Detention:

Carriers must notify 1 hour prior to detention starting for approval (2 hours free time). Detention will not be paid on FCFS loads or missed appointments.
Signed/Stamped BOLs must be submitted on the day of detention occurrence for compensation. Detention is not valid without a check-in and check-out times on the BOL.

<3> Updates must be given upon pick up and delivery.

<5> Lumper or any accessorial charges must have proof of payment accompanying the invoice for reimbursement. If VWL provided payment for the accessorial charge and proof of payment is not attached to the invoice, the amount will be deducted from the payout.

<6> Driver must accept Macropoint tracking before they arrive at the shipper and throughout the load. The carrier will be fined \$200 if the driver does not accept Macropoint or if the driver cancels the tracking while en route to delivery.

<7> Missed pickup or delivery appointments are subject to a \$300 fine for each.

<8> Under no circumstances is the carrier permitted to double/co-broker the load.


