- 7. In the event of a shortage or damage NTG must be notified immediately or carrier assumes all responsibility for OSD.

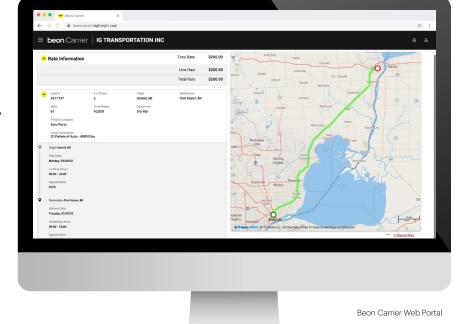
