 - **ALL BOLs ARE DUE 24 HOURS AFTER DELIVERY TIME. Please remit your copies today to avoid rate reduction fees that are now applicable.**
 - The **CARRIER** must send PICS of POD same day for crosscheck purpose that Consignment is delivered safely and nothing is wrong with consignment. All Paperwork must be submitted within 48 hours of delivery or \$100 fine Complete paperwork required. Must include ALL pages of each BOL.
 - By signing this agreement or by picking up and taking possession of the shipment , **CARRIER** agrees to all the terms and conditions as outlined in this rate confirmation. No oral agreements exist.
 - **The CARRIER** and its drivers are responsible for accepting Load tracking request before starting trip.
 - **The CARRIER** and its drivers are responsible for verifying the contents, counts, conditions, loading, weight, proper weight distribution per axle, blocking, bracing, and securement of each load for transportation.
 - **The CARRIER** and its drivers responsible for attaching a seal provided by the shipper to each shipment and ensuring the seal is not tampered or broken during transit. Bills of Lading (BOL) must indicate. The Shipments which are pre-loaded and sealed or whereas the driver is not permitted on the dock to witness the loading or counts are required to be marked on the BOL.
 - **The CARRIER** and its drivers are responsible if the bills are not marked appropriately (as stated) and the load delivers short, your company will be claimed /or short paid the value of the product even if the Seal is marked "In Tact".
 - **The CARRIER** and its drivers responsible for All trailers shall be inspected before loading to ensure compliance with standard food safety. Due to federal, state and local regulations which govern food grade commodities, if the shipment container is damaged, breached, exposed to outside elements, or the seal is broken during shipment the customer may reject the entire shipment
 - **The CARRIER** and its drivers responsible for maintain Reefer Temperature. Always refer to BOL for the required reefer temperature. Such stated temperature on the BOL is to be continuously maintained. If BOL temperature is different than Ryaan Logistics Group LLC Confirmation sheet **CARRIER** shall notify Ryaan Logistics Group LLC immediately.
 - **The CARRIER** and its drivers responsible for notifying Ryaan Logistics Group LLC within 24 hours of any accessorial charges or Lumper fees. ACCESSORIAL RECEIPTS, INCLUDING LUMPERS, must be submitted with original paperwork for REIMBURSEMENT.
 - **The CARRIER** Requests for detention or layover must be submitted within 24hrs. Loading or Unloading Detention starts after 4 hours and payout once get approved by shipper. Carrier must provide a written certification of detention time signed by the responsible party indicating time in and time out on the BOL
 - **The CARRIER** and its drivers responsible for REPORTING AND NOTIFICATION to Ryaan Logistics Group LLC for all event of any accident, theft, delay, or other situation overage, shortage, and damage to immediately. And also noted on the POD, so that we can notify the Customer.
 - It is agreed that Ryaan Logistics Group LLC has the right to hold any payment owed to the carrier in the matter of an unresolved claim that has not been settled.

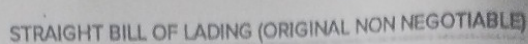
