1. Unless otherwise approved by Schneider, the above rate includes all stop-off charges, fuel surcharges, loading, unloading, etc. This rate cannot be changed, modified, or supplemented by reference to any other rates, rules, classification, schedule, or tariff without Schneider's written permission.

2. Any accessorial not listed above (including, but not limited to, labor, detention, layover charges, etc.) must be pre-approved by Schneider; failure to obtain pre-approval will result in non-payment. Driver detention times charges must be clearly noted on the bill of lading and may only be authorized on electronically tracked Shipments (Schneider's customers require electronic tracking for Shipment updates). ### Additional Requirements

2. Carrier is required to adhere to all appointment times set by the Customer (and, if requested by the Customer, ensure that the driver has the necessary technology to provide (and agrees to provide) tracking of the Shipment via mobile app technology).

3. Brokerage of this Shipment by Carrier is prohibited. Any brokerage will void Schneider's obligation to pay Carrier.

4. Carrier's dispatch personnel must notify Schneider immediately of any Shipment related issues that will, or are reasonably likely to, cause Carrier to miss the scheduled pick-up or delivery appointment time. Carrier must contact Schneider (do not call the customer) at 855 476 4786 with any Shipment related concerns.

5. Carrier shall not break the seal, partial the Shipment, or move the Shipment via rail without written consent from Schneider. This will result in non-payment, a claim and/or legal action per the terms of the Master Transportation Agreement.

#### Supply Chain Security Form

- All loads parked unattended overnight must be secured in a locked, fenced-in and welllighted lot. All secure, safe locations must have a 24/7 security guard operations and CCTV coverage. Under no circumstances is an open lot, public street or highway, or truck stop acceptable for overnight, unattended parking. Avoid parking in an area dimly lit and hidden from view.
- Drivers will not discuss details concerning the load they are carrying with any unauthorized. personnel nor be accompanied by any unauthorized personnel during the trip.
- Drivers are responsible to lock their tractors when stopping and not have the motor running in their absence.
- If in an emergency a Johnson & Johnson load is to be dropped, it must be padlocked, and the trailer backed against a building or another trailer in such a manner that entry into the trailer is prohibited [restricted]. Kingpin or Suzy Locks to be used on the "Fifth wheel" trailer coupling if trailers are to be dropped.
- Drivers do not stop for first 200 miles upon leaving the terminal unless an emergency has HOS implications. If a driver needs to stop within 200 miles notify dispatch and identify a safe stopping zone.
- Ensure that fuel tank is full when picking up a J&J load.
- All drivers will present their driver's license at the distribution welcome center along with shipping documents containing the seal numbers.
- The driver assigned to the load must stay with the load and deliver it direct to the consignee named in the Bill of Lading unless it is a relay team scenario.
- At the beginning of each day and stop, the seals and locks on all trailers will be checked for tampering and recorded as to date and time of check with the driver's initials next to each entry on the bill of lading.
- High-Value loads (defined as those who's that have a retail value that is \$1mm or more by Johnson & Johnson) shall require air brake locking mechanisms and GPS/GSM telematics equipped trailer and tractors.
- Drivers will be responsible to lock the air brake systems on million dollar loads at every stop and take the key with them when leaving the tractor for any reason.
- Drivers will be responsible to immediately report a loss of the load and/or tractor to their disnatcher and then remain at the scene to report the incident to the police having iurisdiction of the area in which the load was stolen.
