

### **Terms and Conditions**

The Broker-Carrier Agreement or Carrier Agreement (in each case, the "Agreement") between Coyote Logistics, LLC, a Licensed Property Broker - USDOT # 2236410, and ROYAL3 INC is amended by the verbal agreement between Jared Soderholm of Coyote Logistics, LLC hereafter referred to as BROKER, and Jason Corkovic of ROYAL3 INC hereafter referred to as CARRIER, dated 07/12/2024.

This confirmation is subject to the terms of the Agreement and this document constitutes an amendment thereto. If the CARRIER has not signed the Agreement, then the rate shown above is the agreed individually negotiated rate and no other rate shall apply including any carrier tariff rate or terms.

THIS LOAD SHALL NOT BE DOUBLE BROKERED. No additional charges not listed above may be added by the CARRIER. Any additional charges must appear on a revised confirmation sheet signed by the BROKER. CARRIER must include signed copy of the shipper's bill of lading and any other proof of delivery with invoice to BROKER. Rates, except as specifically designated above, are inclusive of any fuel surcharge. CARRIER certifies that it is in compliance with all requirements of the California Air Resources Board (CARB) that are applicable to the scope of CARRIER's operations, including, but not limited to: Statewide Truck and Bus Regulations, Transport Refrigeration Unit (TRU) Regulations, Tractor-Trailer Greenhouse (GHG) Gas Regulations, and Drayage Truck Regulations. CARRIER also warrants that it is in compliance with any comparable requirements of the Environmental Protection Agency (EPA) and other states, where applicable. CARRIER shall be responsible for any fines imposed on BROKER and/or shipper resulting from noncompliance.

CARRIER hereby confirms that it maintains applicable and valid insurance without exclusions that would prevent coverage for the items listed above. CARRIER has at least \$100,000.00 in cargo insurance and \$1,000,000.00 in automobile liability coverage. CARRIER further confirms that in transporting the shipment described hereinabove, it will comply with all U.S. DOT and FDA regulations applicable to its operations while transporting said shipment, including, but not limited to drivers' hours of service, and the Food Safety Modernization Act (FSMA), if applicable. CARRIER agrees to the attached requirements from the shipper, if any.

#### ALL LOADS ARE SUBJECT TO ELECTRONIC TRACKING

By accepting this shipment, CARRIER agrees that it has obtained a written agreement from each driver transporting a shipment tendered by BROKER to CARRIER pursuant to the Agreement in which each driver provides all necessary consents to (i) receiving text messages and/or phone calls from or on behalf of BROKER and (ii) allowing BROKER or its vendor to track such driver's location while transporting such shipment. CARRIER shall comply with all applicable laws relating to the collection, use, storage, retention, disclosure, and disposal of any information CARRIER provides to BROKER, including information regarding the drivers transporting shipments. CARRIER shall indemnify, defend, and hold BROKER and its affiliates harmless from and against any and all claims, damages, liabilities, losses, actions and expenses (including attorneys' fees) arising out of or in connection with CARRIER's breach of this Section. This Section shall survive the expiration or termination of the Agreement between BROKER and CARRIER.

# Operating Parameters S. C. Johnson & Son, Inc. ("SCJ")

### Carrier shall adhere to the following customer requirements:

Carrier shall allow SCJ to audit the Carrier's compliance, with the terms, conditions and standards of service.

Carrier is responsible and liable for any and all costs and damages arising from any Incidents or loss of load, including any response and environmental remediation required as a result of a Discharge (including disposal of any Product resulting therefrom in accordance with SCJ's standard procedures). Carrier assumes sole responsibility, regardless of the party that loaded the Product, to ensure that each Shipment is not overweight.

<u>Recovery for Loss or Damage</u>. Carrier shall immediately notify Broker of damage to or loss of Product and Broker shall report to SCJ and obtain SCJ's prior approval regarding what to do with such Products. Carrier may not sell Product for salvage value.

**Carrier shall** maintain all tractors, trailers and any other vehicles and Equipment used to provide services hereunder in roadworthy condition and in a manner consistent with good business practices, industry standards, and in compliance with applicable Laws and all applicable Permits, particularly with regard to:

- a) the replacement of tires and brakes;
- b) legal weight limits for highway transportation;
- c) the removal of accumulated ice or snow from exposed surfaces of any Equipment (regardless of whether any such trailer or container is delivered or dropped-off at an SCJ's facility for loading); and
- **d)** properly securing all loads;

Carrier shall comply with, and be bound by, SCJ's Supplier Code of Conduct (as amended by SCJ from time to time, the "Code"), immediately notify SCJ in writing if it fails to comply with the Code, and upon request, certify in writing its compliance with the Code to SCJ. SCJ shall have the right to audit Carrier's compliance with the Code at any time. The Code is, and any amendments thereto may be, available at the following website:

#### **Customs**:

The Carrier shall comply with all applicable Laws and administrative customs requirements regarding the reporting and transporting of goods being imported and exported from the United States and/or Canada, and transported through the United States and/or Canada, including the Reporting of Imported Goods Regulations, the Reporting of Exported Goods Regulations and all other applicable Laws concerning control, prohibition or regulation of imported or exported goods.
- b. Where Carrier provides services for cross-border Shipments, it shall agree to the terms of the Customs-Trade Partnership Against Terrorism ("C-TPAT") Agreement to Voluntarily Participate, and represents and warrants that it has implemented a supply chain security program in accordance with the C-TPAT security recommendations, and has obtained, and will maintain certified member status with C-TPAT. If certification of Carrier lapses or is otherwise terminated, Carrier shall promptly notify Broker who in turn will notify SCJ. Certification status may also be monitored by SCJ through a third party and Carrier agrees to coordinate with such designated third party. Carrier shall further represent and warrant that it has registered with the Canada Border Services Agency.
- c. Carrier shall implement and maintain any and all applicable security measures established by the U.S. Customs and Border Protection ("CBP"), including the C-TPAT Highway Carrier Security Criteria, in each case, as amended.

Carriers must adhere to the guidelines attached and may be required to complete other documents/questionnaires when arriving at shipping/receiving locations.

If drivers fail to pass requirements, they will be turned away from the facility. A driver's failure to pass the customer's requirements and/or the carrier's failure to make drivers aware of this requirement at the time of dispatch could result in Coyote denying any TONU charges or requests for additional costs stemming from rejected drivers.
