2. In the event of a delay exceeding 24 hours, carrier must arrange recovery of freight or allow Stett Transportation to arrange for recovery, at carriers expense, to avoid claim.

3. In the event a load is reconsigned after dispatch, carrier will authorize reconsignment and the following fees will apply: \$1.50/mile for the additional miles.

4. Double brokering or interlining is prohibited and will void this agreement and carrier will forfeit payment.

9. All reefer setting discrepancies between bill of lading and rate confirmation must be reported prior to departure from shipper or will be responsible for any damage or claims.

10. Trailers must be loaded to maximum legal capacity. Carrier will forfeit payment and pay entire amount of claim if load was not loaded to full legal capability.

11. Produce loads without padlocks are subject to a \$500 fine.

12. Carrier is responsible for securing load prior to departure (load/bar locks, etc).

13. All accessorials must be reported to Stett Transportation at the time of occurence or costs will not be reimbursed. 14. Unless Stett Transportation provides written notice herein that this term does not apply to this shipment, carriers motor vehicle equipment shall be dedicated to brokers exclusive use while transporting freight tendered by broker (Stett Transportation) pursuant to this load confirmation and carriers agreement with Stett Transportation. Carriers violation of this exclusive use requirement shall result in carriers forfeiting its right to be paid for the transportation services contemplated by this load confirmation, not as penalty, but as liquidated damages.

15. Carrier will be responsible for fines or penalties from shipper, consignee, or consignor.

16. Weights are estimated; carriers should scale prior to leaving shipper.

17. Carriers must change appointment times through Stett Transportation.

18. By accepting this rate confirmation, carrier certifies compliance with CARB Transportation Refrigerated Unit (TRU) equipment requirements on any applicable trailers on California roadways. 19. Carrier and its representatives shall not solicit traffic from any customer of the broker if these lanes became known to the carrier through the brokers efforts.

20. This agreement shall be deemed to have been drawn in accordance with the statutes and laws of the state of Kentucky. In the event of any disagreement or dispute, the laws of Kentucky shall apply. All such disagreements or disputes shall be submitted to the court of proper jurisdiction in the state of Kentucky and the parties hereby agree to the exclusive jurisdiction of the courts located in the state of Kentucky. Notwithstanding the foregoing, the parties may mutually agree in writing to submit any such disagreement or dispute to binding arbitration.
