Detention payment does not begin for at least 3 hours unless otherwise agreed to in writing. To qualify for additional compensation, the Carrier MUST notify TQL at least 30 minutes before beginning detention time and when arriving-on-time/departing from all shippers/receivers (unless the shipper/receiver will notate check in/out times on the paperwork). TQL reserves the right to deny all additional charges unless communicated in advance writing and invoiced to TQL within 90 days of load completion. All demurrage, detention, and per diem charges must be communicated to TQL in writing within 30 days of load completion in order to validate and/or dispute with the steam ship line directly. TQL reserves the right to deny all demurrage, detention, and per diem charges communicated more than 30 days from invoice date. Carrier must file any disputes in regards to demurrage, detention, and per diem charges in writing with the billing party within 7 days from date of invoice.

#### **Carrier Requirements:**

- Carrier must fill out and return a "TQL security form" prior to being dispatched.
- Driver must accept and maintain TQL's Carrier Dashboard/Macropoint/Project44 Tracking for the duration of the shipment.
- Driver(s) must send picture of BOL to starbucksteam@tql.com prior to leaving shipper.
- Reefer loads only: Trailer must be pre-cooled to temperature advised by TQL prior to arrival at the shipper.
- Appointment times are strict.
- Driver must maintain professionalism through the entirety of the load.
- Contraband is strictly prohibited which is including but not limited to; drugs, alcohol, weapons.
- Driver must comply with all safety instructions while at facility.
- Any fees charged due to non-compliance with TQL, or shipper/receiver instructions will be the responsibility of the carrier.
- In the event of a breakdown, accident, or delay in transit driver(s) must contact TQL immediately upon occurrence.
- In the event of a breakdown, accident, delay in transit or any OTR incident that jeopardizes on time delivery may request to repower your trailer to help mitigate potential claims or consequential damages.
- Late delivery may result in non-payment of freight charges, and special damages as a consequence of being late may apply; this includes, but is not limited to, freight charges for expedited shipments, packaging materials, additional labor charges, storage charges, spoiled product, loss of sale, the expense of any additional equipment, service, or alternate transportation arrangements that need to be utilized as a result of late delivery.

#### **Equipment Requirements:**

- 53' trailer with swing doors is required.
- Load is subject to the requirements of the Food Safety Modernization Act (FSMA). Carrier is solely responsible for the sanitary condition of the product during transit and certifies that trailers are appropriate for the goods transported, comply fully with FSMA standards, are clean, sanitary and expected and that refrigeration (if required) is operational and will maintain the required temperature. Carrier certifies compliance with all training and record keeping requirements of FSMA.
- Trailer must be food-grade: clean, in sound physical condition, odor free, dry, leak proof, and free of contamination/infestation.
- Trailer must be a dry van UNLESS the load is refrigerated and requires a reefer. Reefers arriving for a dry load will be rejected.
- Exclusive use of the trailer is required, and the load cannot be run as a partial.
- Trailer is subject to shipper inspection must be food grade and completely free from any debris or contaminants remaining on floor of trailer.
- Carriers that previously hauled any debris-causing commodities (e.g. hay) must have a washout completed before arriving to shipper.
- Trailers with debris present will not be loaded; driver will be rejected until washout is completed.
- If trailer is rejected due to incorrect/unsuitable equipment, no TONU will be paid.

#### Seal Requirements:

- Shipper will apply trailer seal.
- Seal numbers must be PRINTED on BOL (Handwritten is not sufficient).
- Trailer must be locked and sealed prior to leaving the shipper.
- · Driver must verify that all identifying seal numbers match those printed on the BOL before departing shipper.
- Driver cannot cut, remove, alter, or in any way tamper with seal once placed on trailer.
- Contact TQL immediately if load is not sealed, do not leave shipper without seal.
- Driver(s) must utilize the V.V.T.T. Seal verification method prior to leaving the shipper or any approved stop in transit.
  - View the seal and locking mechanism.
  - Verify Seal Number for Accuracy.
  - Tug on the seal to make sure its affixed properly.
  - Twist and turn the seal to ensure it does not unscrew.
- Driver must be able to send photo of seal to broker within 30 minutes of any check call where seal confirmation is requested.
- Only an employee of the receiver should break seal.
- · Arriving to receiver with non-matching or broken seal may result in a full truckload rejection and cargo claim.

#### **Accessorial & Detention Requirements:**

- Detention begins after 4 hours.
- Broker will pay agreed-upon accessorial bonus and noted on Rate Confirmation as long as the following criteria are met:
  - Tracking remains active the entirety of the shipment (from dispatch to delivery/confirmed empty).
  - Load arrives to receiver in compliance with seal protocol: same seal attached to door of same trailer that departed origin
    arrives to receiver with matching paperwork and witnessed intact by receiver prior to removal.
  - Eligibility and verification of completed requirements are at the discretion of the broker.





- Driver must be checked in on time for their appointment or within the FCFS window to be eligible for detention.
- Carrier must send an email to <u>starbucksteam@tql.com</u> 30 minutes prior to detention time starting.
- Check IN/OUT times must be notated on BOL and sent to <u>starbucksteam@tql.com</u>.
- Reefer loads only: Trailers must arrive at shipper pre-cooled to temperature advised by TQL to be eligible for detention.
