Whitewater Freight, Inc. - Rate Confirmation Agreement



This confirmation is an addendum to any prevailing Motor Contract Carrier Services Agreement between Whitewater Freight and the Carrier. All rates and charges listed are final unless contested within 24 hours of receipt.

Tracking Requirement: Carriers are mandated to use our Macropoint account tracking via ELD or Phone App, ensuring timely and efficient load transit. Tracking must commence 4 hours before loading, with non-compliance incurring a penalty up to \$250.

Acceptance of Terms: By accepting this load, the Carrier agrees to abide by the terms outlined here and at www.whitewaterfreight.com/tc. It is the Carrier's responsibility to inform all drivers of these terms.

Vehicle Identification: Vehicles must display signage that corresponds with the Carrier's name as stated in this rate confirmation to avoid forfeiture of shipment and reporting of double brokering.

Pick up and Delivery Scheduling: Unauthorized deviation from the pick up or delivery time will result in chargebacks to the responsible party. The chargeback rate is \$300 per day for each day the delivery is early or late without prior approval from Whitewater Freight.

Cargo Security

Security seals must not be broken without prior authorization. Unauthorized tampering with seals may result in cargo rejection and a fine of \$500.

Compliance: Carriers must comply with all applicable laws and regulations and will bear responsibility for any infractions resulting in fines or penalties. The Carrier must not undertake any action at the request of any party that violates legal or safety standards.

Legal Operation: The Carrier is responsible for ensuring the safe, legal, and proper operation of their vehicle at all times. Any instruction from Whitewater Freight that contravenes legal requirements must be disregarded, and Whitewater Freight must be informed immediately.

Communication Protocol Acknowledgment: By executing this agreement, the Carrier and their drivers confirm their capability to lawfully receive text messages dispatched by Whitewater Freight, Inc. It is imperative to understand that engaging with text messages while operating any vehicle poses significant risks of injury, death, or property damage. The Carrier, the driver, and all related personnel are obliged to review and respond to such communications exclusively when the vehicle is securely parked and stationary.

The Carrier and all associated individuals fully assume responsibility for compliance with this protocol and pledge to adhere to all relevant federal, state, and local regulations concerning the management of mobile communication devices. This includes the reception, perusal, and dispatch of text messages, phone calls, or the transfer of any pertinent information to or from Whitewater Freight. Furthermore, the Carrier agrees to exonerate and defend Whitewater Freight against any claims that may arise in connection with the transportation of loads, any breach of the terms of this Rate Confirmation Agreement, or the overarching Broker-Carrier Agreement, to the maximum extent allowed by law.

Billing Procedures: Email all Proof of Deliveries and Invoices to AP@whitewaterfreight.com.

Reference the order number in the email subject line.

Paperwork must be submitted in 48 hours of delivery or there will be a \$50.00 fine.

Quick Pay Option

A Quick Pay option is available at a 3% fee (minimum \$15), to be paid via ACH one business day after all necessary paperwork is received. This option remains active for subsequent orders unless a cancellation is requested. This service is exclusive to companies holding US Bank Accounts.

No Shared Loads: Unless otherwise specified, the client's cargo will not be combined with cargo from other clients during the transportation process, ensuring dedicated service and priority delivery. A fine of up to 50% of order will be applied.

Non-Substitution of BOL Policy: Rate confirmations provided by Whitewater Freight may not be used as a substitute for the Bill of Lading under any circumstances. The rate confirmation outlines the agreed-upon charges and terms but does not replace the BOL. Failure to deliver on a proper Bill of Lading, and attempting to use a rate confirmation as a substitute, will result in a \$200 fine per occurrence. This fine will be applied to the responsible party's account.
