

Rate Confirmation Agreement for Tetria Global Logistics, LLC

Steps to ensure timely and full payment:

- 1. Accept electronic rate confirmation
- 2. Accept macropoint tracking request possible \$150 deduction per day if non-compliant
- 3. If Macropoint is not accepted, daily tracking call must be made or \$25 day per day penalty
- 4. After delivery, submit SIGNED (Shipper & Receiver) POD using LogixAnywhere App to upload signed BOL
- 5. Send SIGNED POD and Carriers Invoice to CarrierInvoice@Tetria.com
- 6. DELIVERING CARRIER IS RESPONSIBLE FOR ALL LATE/RESCHEDULING FEES. DEDUCTIONS FOR LATE DELIVERY MAY BE APPLIED AT BROKERS DISCRETION

Lumper - requires paid receipt for reimbursement

Detention - must show in/out times signed by shipper/receiver and submitted within 24 hours
