To qualify for additional compensation, the Carrier MUST notify TQL at least 30 minutes before beginning detention time and when arriving-on-time/departing from all shippers/receivers (unless the shipper/receiver will notate check in/out times on the paperwork). TQL reserves the right to deny all additional charges unless communicated in advance writing and invoiced to TQL within 90 days of load completion. All demurrage, detention, and per diem charges must be right to deny all demurrage, detention, and per diem charges communicated more than 30 days from invoice date. Carrier must file any disputes in regards to demurrage, detention, and per diem charges in writing with the billing party within 7 days from date of invoice.

Entering the Yard

- Be cautious at all times!

§If any accidents or incidents occur on Sappi property, let shipping and or the guard shack know immediately.

- Obey the posted speed limit signs
- Check in with the guard shack at entrance
- Be aware of the four rail tracks that run through our main entrance, always stop and look before attempting to cross the tracks. Once in the process of crossing, do not stop or delay over the tracks.

§The train always has the right of way

- §Note, three of the four tracks DO NÓT have crossing arms, and instead are only equipped with flashing lights. (Drivers must be extra cautious in this area)
- Enter the shipping office and let them know the load # being picked up and whether or not you have an empty
- Communicate with the shipping office/yard jockey to determine where to park your empty

§Slide tandems all the way back and lock them into place. If not slid, the trailer will be rejected

§If parking in the yard, leave a minimum of a two foot space on both sides

§If instructed by the shipping crew to place the empty into the docks the driver must also:

·Chock tires

·Put down jack stands under trailer nose

·Disconnect tractor from trailer

·Pull tractor off to side of the driveway or park across the road in the lot. (Tractors cannot stay hooked to trailer while loading unless the truck is shut off and the driver waits inside the gated area by the shipping office)

#### ·Trailer Rules

- Drivers must inspect the empty trailer before dropping.

§Floors must be swept and the floor must be free of nails and or other dunnage

§Interior trailer walls are to have no metal, etc. protruding from the wall, as it could snag and damage product.

§Trailer must be properly sealed to provide a moisture free environment.

§Trailers must have ICC bars that allow our dock lock to engage the equipment.

§If trailers do not meet our standards we will reject them

#### ·Driver Rules

- No tobacco use of any form allowed on Sappi property
- Drivers are not allowed beyond the gated area at the shipping office entrance

§If waiting for a load, the driver must either wait in his truck or in the gated area.

#### ·Exiting the yard

-All outbound loads should weigh at the scale to ensure the load or axles are not overweight (located adjacent to the guard shack near the mill entrance)

-Export Loads

§Obtain delivery paperwork from shipping

§Find trailer and scale the load

§Then return to the shipping office to obtain the customs paperwork. (It is important that drivers scale export loads before asking for the export paperwork)
