2. ALL CONTRACTED DRIVERS MUST REPRESENT THEMSELVES AS C&M EXPRESS LOGISTIC / TRUCKLOAD.

3. ONLY ORIGINAL SHIPPERS BILL OF LADING WILL BE ACCEPTED AS PROOF OF DELIVERY WITH LEGIBLE SIGNATURE. C&M WILL NOT ACCEPT ANY CARRIERS IN HOUSE PAPERWORK AS PROOF OF DELIVERY. USE OF ANY PAPERWORK OTHER THAN ORIGINAL SHIPPERS BILL OF LADING CAN DELAY PAYMENT OF FREIGHT. DRIVER MUST WRITE "C&M EXPRESS LOGISTICS" WITH THE C&M PRO NUMBER FOR LOAD ON ALL BILL OF LADINGS.

4. C&M REQUIRES CALLS FOR ON SITE SHIPPER / LOADED WITH PCS COUNT, WEIGHT, AND BOL / ON SITE CONSIGNEE / POD. ANY AND ALL DETENTION, LAYOVERS AND CHANGES TO ORIGINAL LOAD REQUIREMENT MUST BE APPROVED BY C&M EXPRESS LOGISTICS. TWO (2) HOURS FREE FROM TIME OF PICK OR DELIVERY IS REQUIRED BEFORE CHARGEABLE DETENTION AND REQUIRES A NAME OF PERSON ON SITE - ALONG WITH IN AND OUT TIMES SIGNED. ALL DETENTION CHARGES MUST BE APPROVED AT THE TIME OF OCCURRENCE AND NO LATER THAN 24 HOURS AFTER THE FACT. 8. INDEMNIFICATION. Without regard to the insurance limits in Section 8 of carrier agreement, CARRIER shall defend, indemnify and hold BROKER harmless against any claims, actions or damages, including, but not limited to, cargo loss, damage, or delay, and payment of rates and/or accessorial charges to Carriers, arising out of CARRIER's performance under this Agreement, including but not limited to the actions of any driver, employee, contractor, sub-carrier, owner/operator, or other agent of CARRIER or party performing any of CARRIER's obligations under this Agreement. CARRIER shall be liable to BROKER for any claims, actions or damages due to the negligence of BROKER. The obligation to defend shall include all costs of defense as they accrue, including reasonable attorney's fees.

9. Accessorial charges must be pre-approved and noted in writing or they will be rejected. For wait time, bills of lading must be marked with IN and OUT times from shipper/consignee. Detention/Layover will be negotiated at time of occurrence, not to exceed \$250. MAXIMUM DETENTION IS \$250.



