- You MUST call bm2 IMMEDIATELY if there is any discrepancy between bol and the rate confirmation. This would include, but is not limited to temperatures, addresses, weights, or quantities.
- Immediately notify BM2 Freight of any overages, shortages, and/or damages.

### FREIGHT OPERATIONS

- Double brokering or sub-leasing of any shipment without written approval will result in non-payment.
- If carrier is picking up or delivering in or out of the state of California, Carrier or its agent certifies that the TRU equipment furnished for loading this Shipment is compliant with California Regulations.
- Additional accessorial charges must be communicated at time of occurrence and all receipts must be submitted to your BM2 carrier rep for approval within 24 hours.
