All Van/Container loads MUST be sealed at origin either by shipper or driver with a seal number noted on bill of lading. The driver is responsible for re-sealing the trailer after each pickup/drop on a multi-stop shipment. In the event a shipment that was sealed at origin or after each additional pickup/drop arrives at the destination with a tampered seal or without the seal intact then (i) the Carrier shall be liable for any shortage or damage claims with respect to such shipment and (ii) the shipper shall have the right, in its sole discretion, to deem the entire shipment damaged, adulterated/contaminated and unsalvageable, without the need for any inspection and the Carrier shall be liable for the full value of the shipment. Carrier is required to weigh shipment within 50 miles of departing each shipper. If carrier fails to weigh shipment within 50 miles of departing each shipper, any citations/expenses incurred due to the equipment and/or shipment weight will be the carrier's sole responsibility. Carrier must meet and comply to shipper requirements at the facility. All drivers must wear masks or facial coverings to the extent required by laws or facilities. Carrier must be in full compliance with the Food Safety Modernization Act (FSMA), if applicable. By accepting the shipment, Carrier agrees that the driver has consented to receiving text messages and/or phone calls from or on behalf of Coyote.

Approval for payment of detention is contingent upon the following eligibility requirements:

- 1) Carrier must report facility departure time and total detention hours within 24 hours of shipment delivery at the final facility.
- 2) Carrier must provide proof of the on time arrival and departure times in the form of a BOL or other shipping document with arrival and departure times notated by facility within 24 hours of shipment delivery at final facility.

Terms and Conditions

The Broker-Carrier Agreement or Carrier Agreement (in each case, the "Agreement") between Coyote Logistics, LLC, a Licensed Property Broker - USDOT # 2236410, and BRZ is amended by the verbal agreement between Jared Soderholm of Coyote Logistics, LLC hereafter referred to as BROKER, and Alex Pearce of BRZ hereafter referred to as CARRIER, dated 10/01/2024.

This confirmation is subject to the terms of the Agreement and this document constitutes an amendment thereto. If the CARRIER has not signed the Agreement, then the rate shown above is the agreed individually negotiated rate and no other rate shall apply including any carrier tariff rate or terms.

THIS LOAD SHALL NOT BE DOUBLE BROKERED. No additional charges not listed above may be added by the CARRIER. Any additional charges must appear on a revised confirmation sheet signed by the BROKER. CARRIER must include signed copy of the shipper's bill of lading and any other proof of delivery with invoice to BROKER. Rates, except as specifically designated above, are inclusive of any fuel surcharge. CARRIER certifies that it is in compliance with all requirements of the California Air Resources Board (CARB) that are applicable to the scope of CARRIER's operations, including, but not limited to: Statewide Truck and Bus Regulations, Transport Refrigeration Unit (TRU) Regulations, Tractor-Trailer Greenhouse (GHG) Gas Regulations, and Drayage Truck Regulations. CARRIER also warrants that it is in compliance with any comparable requirements of the Environmental Protection Agency (EPA) and other states, where applicable. CARRIER shall be responsible for any fines imposed on BROKER and/or shipper resulting from noncompliance.

CARRIER hereby confirms that it maintains applicable and valid insurance without exclusions that would prevent coverage for the items listed above. CARRIER has at least \$100,000.00 in cargo insurance and \$1,000,000.00 in automobile liability coverage. CARRIER further confirms that in transporting the shipment described hereinabove, it will comply with all U.S. DOT and FDA regulations applicable to its operations while transporting said shipment, including, but not limited to drivers' hours of service, and the Food Safety Modernization Act (FSMA), if applicable. CARRIER agrees to the attached requirements from the shipper, if any.

ALL LOADS ARE SUBJECT TO ELECTRONIC TRACKING

By accepting this shipment, CARRIER agrees that it has obtained a written agreement from each driver transporting a shipment tendered by BROKER to CARRIER pursuant to the Agreement in which each driver provides all necessary consents to (i) receiving text messages and/or phone calls from or on behalf of BROKER and (ii) allowing BROKER or its vendor to track such driver's location while transporting such shipment. CARRIER shall comply with all applicable laws relating to the collection, use, storage, retention, disclosure, and disposal of any information CARRIER provides to BROKER, including information regarding the drivers transporting shipments. CARRIER shall indemnify, defend, and hold BROKER and its affiliates harmless from and against any and all claims, damages, liabilities, losses, actions and expenses (including attorneys' fees) arising out of or in connection with CARRIER's breach of this Section. This Section shall survive the expiration or termination of the Agreement between BROKER and CARRIER.

Operating Parameters Bush Brothers & Company

Carriers must adhere to the guidelines attached and may be required to complete t documents/questionnaires when arriving at shipping/receiving locations.

If drivers fail to pass requirements, they will be turned away from the facility. A driver's failure to pass the customer's requirements and/or the carrier's failure to make drivers aware of this requirement at the time of dispatch could result in Coyote denying any TONU charges or requests for additional costs stemming from rejected drivers.

Dear Valued Bush Brothers' Service Providers

With increase concern from the COVID-19 virus pandemic, Bush Brothers has re-evaluated many of our internal practices within our shipping and receiving office areas to ensure increase safety for both our transportation providers and Bush Brothers' operators. All facilities, both internal and external 3PLs have policies in place to ensure increased sanitation and adherence to the CDC and WHO guidelines for respiratory infection control.

Internally, Bush Brothers has implemented the following new procedures to ensure the safety of transportation providers and Bush Brothers operators are the utmost concern:

- Increased sanitation schedules of driver lounge and bathrooms
- Lounge and bathroom are open to drivers only
- Hand sanitizer, sinks with soap and water available in lounge areas
- Limit the number of drivers in the lounge to promote social distancing. No more then 3
- Requesting driver cellphone number upon check-in to ensure expedited direct contact can be made if driver waits in conveyance.
- Installation of clear splash guard barriers between dock office window and driver lounge
- Maintaining social distancing guidelines of 6 feet when checking trailer seals with drivers
- New and updated signage throughout facilities to direct drivers to appropriate areas

In addition to our internal facilities, Bush Brothers' external partners (Greeneville, TN, Hutchins, TX, Tolleson, AZ, and Portland, OR) have all taken precautions at their independent locations. Although, specific procedures may vary slightly, our external Bush Brothers' partners have implemented the following new procedures to ensure driver safety as well:

- Increased sanitation of high traffic areas
- New and updated signage through facilities to direct drivers to appropriate areas and promote social distancing
- Alternative driver check-in, designated waiting areas and/or cell phone contact to expedite load completion process.
- Refusal of drivers providing information and/or observed to have flu-like symptoms including fever, cough, or shortness of breath.
- Elimination of driver access to dock area
- Limiting or elimination of signature requirements to reduce transfer of paperwork between driver and staff.

Bush Brothers and our external partners strive to ensure personnel and driver safety is the utmost concern. We appreciate our carrier base assisting in our efforts and ensuring drivers adhere to the new procedures and provide patience during this unprecedented time.
