6. A \$250 per day rate reduction may be assessed for late or missed appointments/delivery dates without advanced notification to and approval by Lake FX Logistics.

7. Carrier must provide all documentation necessary to support the reason(s) for late or missed appointments/delivery dates before payment is issued.

8. It is the driver's responsibility to obtain a legal weight limit before transporting load to consignee. Any concerns about the weight must be immediately communicated to Lake FX Logistics

9. Drivers are responsible for shipment package-count unless other instructions are given. Any difference must be communicated to Lake FX Logistics before driver leaves the shipper's location.

10. Carrier must notify Lake FX Logistics of any overages, shortages, or damages as they occur. 11. A maximum of \$150 will be paid for a Truck-Ordered-Not-Used fee (TONU) on any load.

Carrier shall provide certificates of insurance upon request. Carrier is a federally licensed authorized for hire interstate motor carrier of general freight, does not have either a "conditional" or "unsatisfactory" safety rating, and is otherwise authorized to provide the contracted services.
