1. All drivers with recycle paper (OCC and DLK) will need to go to gate 1 before going anywhere else.

2. At gate 1 the driver will need to present a valid BOL and Gate Pass with a good release number.

3. The drive will also need to have a BOL. This is required for all drivers going on the road. This should not be a problem. If driver does not have a BOL, then the driver will be asked to leave and come back when they have a good BOL. The driver will give the BOL and gate pass to the guard.

4. With a valid BOL and Release number, the guard can print up a replacement gate pass as needed.

5. If the driver is being live unloaded, the driver will need to keep a copy of the gate pass and exit out and go to the scales and present the gate pass to the scaler.

6. If the driver is dropping the trailer in a drop lot, then the driver will need to place a copy of the gate pass in the back of the trailer before leaving Gate 1.

7. No driver will be allowed to go to Scales or drop lot without going to Gate 1 first.

8. When unloading at Recycle, it is very important that the drivers proceed to the scales to get a lightweight before leaving the mill or going to get loaded with brown paper. DO NOT LEAVE SCALES UNTIL scaler says to do so.
