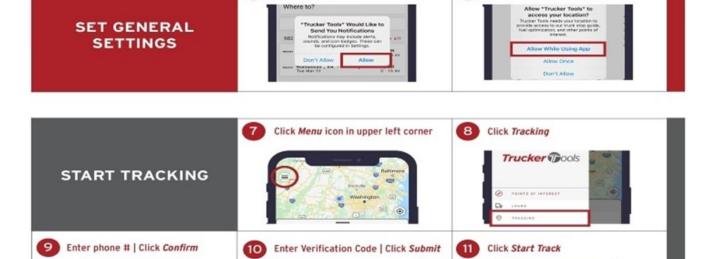
How to Download the Trucker Tools App & Start Tracking

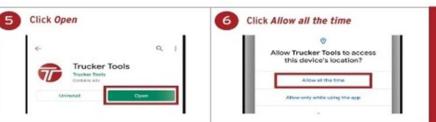


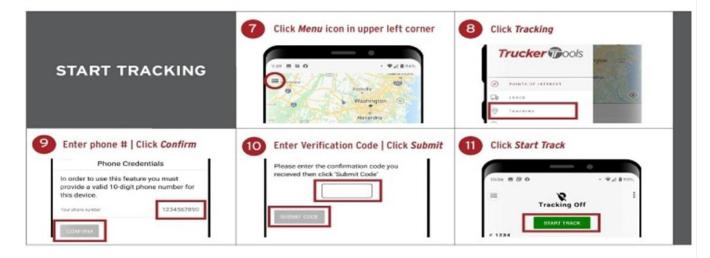
How to Download the Start Tracking
