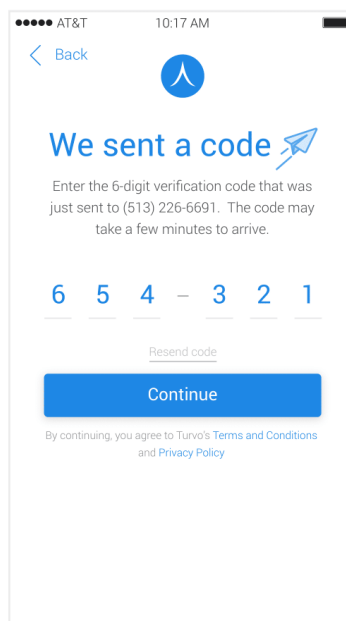
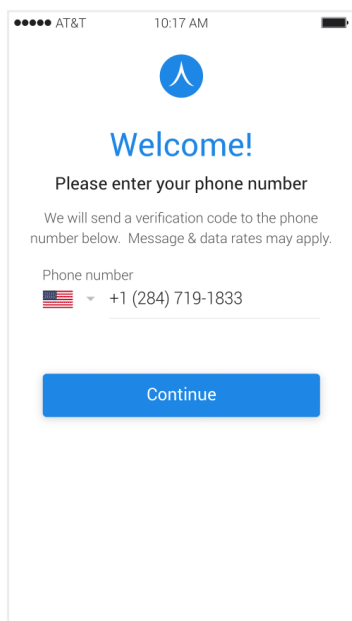
The Turvo Driver app makes it simple to sign-up, view assigned shipments, and get on the road.

- 2 Click the URL to open the App Store or Google Play Store and download the Turvo Driver app.

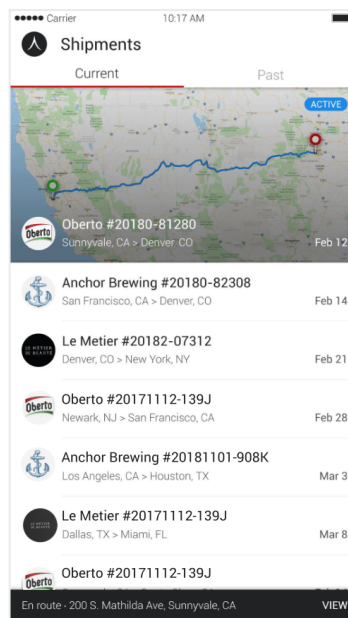
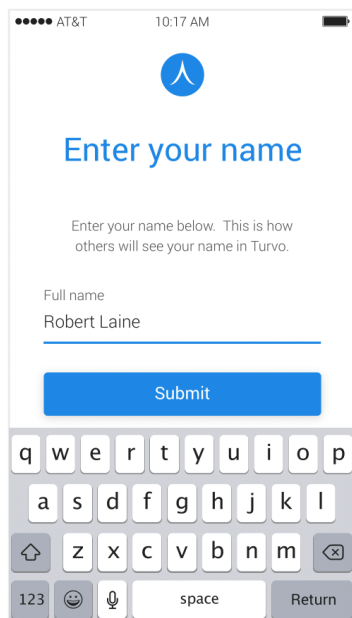

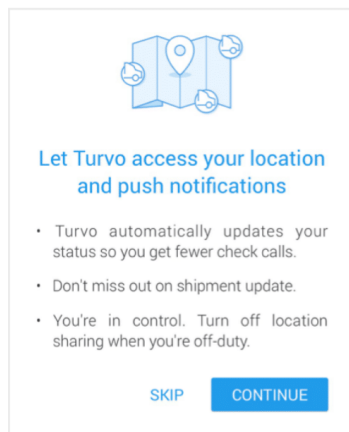
