Under no circumstances can driver leave dock while light is red. In the event of an accident you must not leave mail unattended. If any disruptions happen while transporting this load you must contact usps03@WELCOMPANIES.com.

Failure to arrive w/o padlock or straps will result in \$100 Deduction.  
Any shipments that are more than 500 miles require a team. Failure to pickup with team and any attempt to use a solo will result in a \$500 Deduction.

If you don't check in with both drivers you will be rejected.

Any mechanical issues, delays, or cancellations that result in load needing to be recovered will mean that carrier being replaced will cover difference in cost for having to recover the shipment.

Failure to follow site safety procedures will result in \$100 deduction

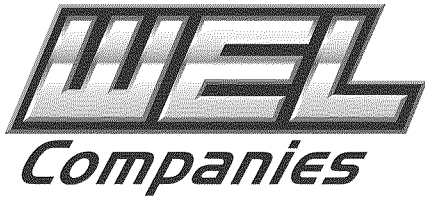
