The undersigned accepts the referenced shipment on behalf of the carrier and acknowledge as the correct information contained herein, the carrier agrees to the terms of the Master agreement previously executed between our companies. Invoicing by the carrier and payment by ACV Freight, LLC, constitutes acceptance of this agreement and creates a valid contract for carriage shipment.

When loading, the driver must count and inspect his/ her load. The Driver / Carrier is responsible for piece count and condition of load at time of delivery. For payment of freight charges, we must receive original and signed Bill of landing and Proof of Delivery with a carrier invoice. Payment will be made 30 days after all required paperwork is received at ACV Freight, LLC. We are not responsible for Overweight.

If Dimensions, Weight, Quantity or type of commodity are different than those consigned in our Load Confirmation Agreement, the carrier MUST notify ACV Freight, LLC. before picking up and request a WRITTEN AUTHORIZATION. ACV Freight, LLC will not pay any extra charges without AUTHORIZATION. 1. Drivers must contact us prior to pick up. 2. Under no circumstances should the carrier or driver representing the carrier contact the shipper without our prior consent 3. Under no circumstances is the carrier permitted to double/co-broker the load, unless approved by us in writing IF done without conscent will result in a full deduction of rate. 4. Pick up and Delivery dates and hours will not require the carrier to violate hours of service regulations. 5. Tracking shipment via Trucker Tools is required on EVERY load. A \$250 fine may be imposed if Driver fails to enable tracking and required to be tracking at all times - Driver must have app installed and signed in one (1) hour prior to the scheduled pickup load if not done will result in a \$100 deduction. 6. ACV FREIGHT IS NOT RESPONSIBLE FOR DETENTION. 7. Driver must fax or email a legible POD within 24 hours of delivery. 8. There may be a fee of \$150 for not sending in copies/faxes of POD's within 24 hrs., and \$150 every 24 hrs until received 9. Send Invoice and Proof of Delivery to our email or fax number. 10. Driver can be fined up to \$100 per day for late deliveries. 11. If Carrier is caught DOUBLE BROKERING, the company will be fined the total load amount. A report will be written and sent into the SAFER website. WE WORK WITH A COLLECTION AGENCY THAT WILL COLLECT ANY UNPAID BALANCES AFTER 30 DAYS. 12. The driver is required to scan BOL with truckertools and send it to the broker if the driver leaves before it is sent they will be deducted \$50, once the BOL is sent call broker. Once the BOL is sent and the driver gets the OK from the broker they are allowed to head to the destination. POLICY IS APPLIED FOR DELIVERY AS WELL. How to activate ELD and send BOL through trucker tools

Activating your Trucks ELD is very simple.

Step 1: Go online to trucker tools website

Step 2: Find the integration tab at the top of the screen

Step 3: Go to the Connect ELD tab (shown below)



Step 4: When you are on the Connect ELD page scroll down and you will see the area to put in all of your information



Step 5: Put in all your information and your ELD will be activated

Sending BOLs through trucker tools is meant to not only save the broker time but also the carrier and driver.

Step 1: log onto trucker tools on your phone

Step 2: Click the 3 lines located on the top left corner

Step 3: Click scan after you have collected the BOL from the pickup site and take a picture of the BOL, select the bill of lading button and submit the BOL
