IMPORTANT NOTES

ATTENTION:

- Send POD's to tracking@shipzeal.com
- Lumper will not be compensated if not included with POD's
- Charges to carrier will apply if Lumper receipt not submitted with POD's

Minimum General Load requirements:

- Must have a minimum of 2 straps and / or load bars to secure the load.
- Any missed appts will be charged accordingly if needed.
- Scale up to 43klbs on Reefer loads
- Dressed appropriately, closed toed shoes
- No calls to shipper/receiver
- Do not force facility to offload your trailer
- On reefer loads always set to continuous never start/stop
- If BOL and rate confirmation have different temperatures, addresses, or product type/pallet count. Notify Zeal Logistics immediately
- Must be tracking on Turvo or Trucker Tools during whole transit time
- If the driver does not comply to tracking we will deduct (\$100.00) dollars from carrier confirmation.
- Must be tracking to get detention/layover approved

- Scale load prior to departure from shipper location if requested. Call your Zeal Logistics Representative before departing shipper, daily before 8am Pacific Time for check call, and at consignee when empty.
- Notify your carrier representative at Zeal for any safety or claims related issues.
- All loads must remain sealed with seal numbers recorded on the bill of lading/delivery receipt.
- If product is being dropped off at agent, Zeal Logistics must give prior approval.
- On dry van only loads, no reefers are allowed.
- POD(s) must be submitted within 24 hours of delivery, failure will result in a \$50 fine.

Detention:

In order to qualify for detention payment, all of the items below must be completed unless otherwise specified in the comments section of this carrier confirmation/rate agreement:

- First 2 hours are free
- \$30 an hour after 2 hours
- Capped at \$150 (upon approval from customer)
- Layover (8hrs or more) \$250
- TONU \$150
- Target/Walmart/Safeway (\$30 after 4 hours)
- Carrier MUST report in and out times to Zeal Logistics at the time of detention
- Notify your carrier representative at Zeal for updates/delays
- In and Out times must be documented on the Bill of Lading for Detention to be approved

Double brokering clause:

- If carrier uses any other carrier to haul Zeal Logistics freight and double brokers, carrier will be freight guarded and load will result in no pay to carrier on this tender
- Double brokering will result in zero paid funds and will be subject to liability penalties.
- Compensation may be withheld if the shipment moved by rail, consolidated with any other freight.

Confidentiality And No Back Solicitation clause:

Confidentiality and No Back Solicitation Customer acknowledges and agrees that the names, routes and pricing of the Carriers and other service providers utilized by Broker are confidential information and are in the nature of a trade secret. Customer shall not directly contact or solicit rates, bids or service from any underlying Carrier or service provider where 1) the availability of Carrier or service provider to perform such services first became known to Customer as a result of Broker's efforts, or 2) where Customer's traffic was first tendered to the underlying Carrier or service provider by Broker. If Customer breaches this provisions and "backsolicits" Broker's underlying Carriers and/or service providers, and/or tenders traffic to such Carriers or service providers, Broker is then entitled, for a period of eighteen (18) months after the involved traffic first begins to move, to payment from Customer of 15% of the gross transportation charges for all such traffic, as liquidated damages. Termination of the relationship between Broker and Customer shall not affect the enforceability and applicability of the foregoing provisions of this clause for a period of two years after termination. By accepting this shipment, you accept the waiver of a carrier's right to enforce provisions off Title 49 CRF 371.3.

Remittance:

- Driver must notify at time of occurrence any accessorial or payment will be denied.
- Zeal Logistics will not be responsible for any accessorial charges not approved at time of occurrence (including lumper fees and detention).
- Additional charges not listed above may not be added by Carrier. Any additional charges must appear on a revised confirmation sheet.
- POD(s) must be submitted within 24 hours of delivery, failure will result in a \$50 fine daily until submitted. Send POD's to tracking@shipzeal.com.

CARB:
