Terms and Conditions This rate confirmation is subject to the terms and conditions of the master Broker-Carrier Agreement ("Agreement"). The rate shown is the agreed individually negotiated rate and no other rates shall apply including any Carrier tariff, rate schedule, or other term or condition of carriage. The rate, unless otherwise stated in the rate confirmation, is inclusive of any fuel surcharge. Any accessorial charges (including but not limited to labor, detention, and/or layover charges) must be pre-approved by Broker in writing. Broker will not provide any reimbursement for unapproved accessorial charges. The rate shown is for a full truckload shipment transported by Carrier. Carrier shall not partial, combine, or consolidate the shipment with any other cargo. Carrier shall not broker or subcontract transportation of the shipment to any third party. Violation of these terms will result in non-payment, and may lead to claims for cargo or other damages, and legal action against Carrier by Broker, consignor, consignee and/or other third parties. It is Carrier's sole responsibility to: (1) follow any special shipping and handling instructions or special equipment requirements provided in this rate confirmation, and immediately contact Broker if Carrier receives any inconsistent instructions; (2) ensure the shipment is in apparent good order and condition and properly blocked and braced, or notate on the bill of lading that Carrier was uninvolved in loading or otherwise unable to count, inspect or secure the shipment; and (3) ensure that trailer seals are applied and remain intact until removed by an authorized employee of the consignee, and immediate contact Broker if the seal is broken for any reason. The rate is contingent upon successful and on-time completion of all terms and conditions of this rate confirmation and the Agreement. The rate is subject to deduction in Broker's discretion if Carrier fails to complete any terms and conditions, or in the event of a rate deduction or fine to Broker resulting from Carrier's act or omission. Notwithstanding anything to the contrary in this rate confirmation or the Agreement, the rate shall not be deducted where Carrier has promptly notified Broker that legal and safe operation prevented Carrier's on-time performance. Carrier must include a signed copy of the shipper's bill of lading and any other proof of delivery with Carrier's invoice to Broker. Failure to submit proof of delivery within fifteen (15) days of delivery will result in a \$150 deduction from Carrier's invoice. Broker will not provide any reimbursement for accessorial or other charges submitted without receipts or other supporting documents, or presented after payment of carrier's initial invoice. The person signing this rate confirmation represents and warrants to Broker that (A) Carrier's insurance policies cover the entire geographic scope in which Carrier will operate, all equipment and drivers Carrier uses to perform, and the type of cargo transported by Carrier pursuant to this rate confirmation; (B) Carrier shall transport this shipment with equipment owned or leased by Carrier and operating under Carrier's operating authority, and subject to the terms of this rate confirmation and the Agreement; and (C) all representations and warranties made by Carrier in the Agreement remain true, accurate and complete in all material respects.

REPLANT POLICY: If there is a need to replant a field of Beck's corn, soybeans, wheat or elite alfalfa, as determined by Beck's staff, Beck's will furnish the seed and royalties FREE! Beck's will <u>attempt</u> to provide the same product for replant as customer originally planted. Substitutions of some products may be necessary. Replant must be planted in the same crop year as originally planted. Great Harvest Organics branded soybeans and wheat are not eligible.

HYBRID SEED CORN:

You may return up to 5% of your total seed corn order taken prior to June 25, 2025 and receive full credit. Any returns over 5% will be charged \$5.00 per unit restocking fee. Any returns over 10% will be charged \$10.00 per unit restocking fee. No returns will be accepted after June 25, 2025. No seed units that have holes, been opened, torn, or tags removed may be returned. Great Harvest Organics units are non-returnable due to certification and unity standards that have to be tracked and maintained.

You may return up to 5% of your total soybean order taken prior to July 1, 2025 and receive full credit if in bags, seed boxes or mini-bulk units. Any returns over 5% will be charged \$5.00 per unit restocking fee. Any returns over 10% will be charged \$10.00 per unit restocking fee. No returns of seed in bulk units can be accepted because of labeling laws. No returns will be accepted after July 1, 2025. No seed units that have holes, been opened, torn, or maintained.

SEED WHEAT:

You may return up to 5% of your total wheat order taken prior to November 1, 2024 and receive full credit if in 50 lb. bags, seed boxes or mini-bulk units. Any returns over 5% will be charged \$5.00 per unit restocking fee. Any returns over 10% will be subject to a \$10.00 per unit restocking fee. No returns will be accepted after November 1, 2024. No returns of seed in bulk units can be accepted because of labeling laws. No seed units that have holes, been opened, torn, or tags removed may be returned. Great Harvest Organics units are non-returnable due to certification and quality standards that have to be tracked and maintained.

REGULAR DUE DATE:

All seed purchases (August 1, 2024 - July 31, 2025) are due August 1, 2025. EXCEPTION:

ALL FIRST YEAR SEED & COD CUSTOMERS MUST PAY FOR THEIR SEED PRIOR TO OR AT THE TIME OF PICK-UP OR DELIVERY UNLESS CREDIT ARRANGEMENTS HAVE BEEN PREAPPROVED. PREVIOUS YEAR SEED ACCOUNTS MUST BE PAID PRIOR TO SHIPMENTS OF CURRENT YEAR PRODUCTS TO ANY CUSTOMER. LATE PAYMENTS AND BAD CHECKS:

All seed accounts unpaid as of August 1, 2025 will be charged 1.25% PER MONTH CARRYING FEE based on the unpaid balance, which is equivalent to 15% ANNUAL PERCENTAGE RATE. A surcharge fee of eight dollars (\$8.00) shall be assessed in addition to the amount of bank fees of twelve dollars (\$12.00) for each unpaid and dishonored check; thus a total of twenty dollars (\$20.00). Notice shall be sent by certified mail and in accordance with Indiana Lode 26-2-7-3. Continued failure to honor the check will expose the maker of the check (customer) to the full range of penalties available under Indiana law, as well as all civil remedies. ENFORCEMENT COSTS:

In the event of default, Buyer agrees to pay all costs, expenses, and attorney fees incurred by Beck's Superior Hybrids, Inc. in enforcing all terms and conditions of this Sales Agreement.

Disputes concerning this agreement shall be resolved according to the substantive law of Indiana. Exclusive venue for such disputes shall be in the state or federal courts for Hamilton County, Indiana, to whose jurisdiction Beck's and customer hereby submit.

BECK'S 0% FINANCING TERMS: Zero Carrying Fees until November 15, 2025 is available with approved credit and a signed promissory note prior to receipt of seed. MISCELLANEOUS POLICIES:

MISCELLANEOUS POLICIES: All purchases (other than seed) are due 30 days after invoice date. If not paid by the due date, the above-mentioned 15% carrying fee will apply. Rabo AgriFinance QuickLink Credit®, John Deere Financial, First Mid Bank and Trust Ag Finance, Discover®, Visa®, American Express® and Mastercard® Buyer understands the price of seed may include packaging or container rental fees per unit of \$0.50 for seed boxes, \$0.12 for mini-bulk bags, and Buyer understands the vice of seed may include packaging or containers. So 10 for wooden skids. Buyer has a duty to exercise ordinary care of rented packaging or containers. Nested seed boxes, wooden skids, empty mini-bulk bags for spring seed must be returned to Beck's facilities by August 1st of the year taken. Nested seed boxes, wooden skids, empty mini-bulk bags for fall seed must be returned to Beck's facilities by March 1st of the following year. Beck's has the option to charge replacement costs for rented packaging or containers not returned by designated time period or any containers that are returned damaged.
