If Carrier fails to provide this notification, then Carrier is responsible for all claims of short or damaged Property.****

DOT'S PRETZELS, GOODYEAR - HERSHEP2: TRACKING IS REQUIRED THROUGH TRUCKER TOOLS. FAILURE TO ACCEPT TRACKING WILL RESULT IN A \$100 FINE. TRACKING MUST BE MAINTAINED AT ALL TIMES DURING TRANSIT. LIVE TRACKING REQUIRED, LOCATION SERVICES MUST BE SET TO "ALWAYS ALLOW." Check in times should be no more than 30 minutes prior to the loading appointment, this helps with smoothing out the loading process for the day. All trailers must be CLEAN and FOOD GRADE, cannot have any ODORS OR BAD SMELLS. If driver misses a pickup appointment, driver will be subject to a \$300 late fee. They are considered DC facilities and is not applicable to these locations.
