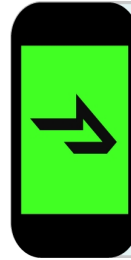

## Terms and Conditions

The Broker-Carrier Agreement or Carrier Agreement (in each case, the "Agreement") between Coyote Logistics, LLC, a Licensed Property Broker - USDOT # 2236410, and ROYAL3 INC is amended by the verbal agreement between Jared Soderholm of Coyote Logistics, LLC hereafter referred to as BROKER, and Jason Corkovic of ROYAL3 INC hereafter referred to as CARRIER, dated 02/13/2025.

This confirmation is subject to the terms of the Agreement and this document constitutes an amendment thereto. If the CARRIER has not signed the Agreement, then the rate shown above is the agreed individually negotiated rate and no other rate shall apply including any carrier tariff rate or terms.

THIS LOAD SHALL NOT BE DOUBLE BROKERED. No additional charges not listed above may be added by the CARRIER. Any additional charges must appear on a revised confirmation sheet signed by the BROKER. CARRIER must include signed copy of the shipper's bill of lading and any other proof of delivery with invoice to BROKER. Rates, except as specifically designated above, are inclusive of any fuel surcharge. CARRIER certifies that it is in compliance with all requirements of the California Air Resources Board (CARB) that are applicable to the scope of CARRIER's operations, including, but not limited to: Statewide Truck and Bus Regulations, Transport Refrigeration Unit (TRU) Regulations, Tractor-Trailer Greenhouse (GHG) Gas Regulations, and Drayage Truck Regulations. CARRIER also warrants that it is in compliance with any comparable requirements of the Environmental Protection Agency (EPA) and other states, where applicable. CARRIER shall be responsible for any fines imposed on BROKER and/or shipper resulting from noncompliance.

CARRIER hereby confirms that it maintains applicable and valid insurance without exclusions that would prevent coverage for the items listed above. CARRIER has at least \$100,000.00 in cargo insurance and \$1,000,000.00 in automobile liability coverage. CARRIER further confirms that in transporting the shipment described hereinabove, it will comply with all U.S. DOT and FDA regulations applicable to its operations while transporting said shipment, including, but not limited to drivers' hours of service, and the Food Safety Modernization Act (FSMA), if applicable. CARRIER agrees to the attached requirements from the shipper, if any.

### **ALL LOADS ARE SUBJECT TO ELECTRONIC TRACKING**

By accepting this shipment, CARRIER agrees that it has obtained a written agreement from each driver transporting a shipment tendered by BROKER to CARRIER pursuant to the Agreement in which each driver provides all necessary consents to (i) receiving text messages and/or phone calls from or on behalf of BROKER and (ii) allowing BROKER or its vendor to track such driver's location while transporting such shipment. CARRIER shall comply with all applicable laws relating to the collection, use, storage, retention, disclosure, and disposal of any information CARRIER provides to BROKER, including information regarding the drivers transporting shipments. CARRIER shall indemnify, defend, and hold BROKER and its affiliates harmless from and against any and all claims, damages, liabilities, losses, actions and expenses (including attorneys' fees) arising out of or in connection with CARRIER's breach of this Section. This Section shall survive the expiration or termination of the Agreement between BROKER and CARRIER.

**Operating Parameters  
RECKITT BENCKISER (“RB”)**

**Carrier shall adhere to the following requirements:**

Carrier shall waive any right to salvage and any right to offset from Shipper’s claim for salvage value. Carrier shall not retain possession of any product or package that has suffered physical damage without the consent of Shipper.

Any person associated with the Carrier who is performing activities in connection with services for RB are required to abide by terms of UPS Code of Business Conduct ([https://www.ups.com/media/en/code\\_bus\\_conduct.pdf](https://www.ups.com/media/en/code_bus_conduct.pdf)).

Carrier shall have no lien, and hereby waives its right to any lien, upon any shipment or portion thereof.

## **1. PURPOSE/SCOPE/LIMITATIONS**

This Agreement constitutes the quality technical agreement required for the transportation of the Contract Giver’s products as well as products of its affiliates and Contract Manufacturing Organisations categorised as Medicines and Medical Devices and materials used in the manufacture and/or packaging of the same (“Products”) and defines the Contract Giver’s and Contract Acceptor’s responsibilities. This Agreement is based on and incorporates the Contract Giver’s requirements as set in e.g.:

- RB’s Global Distribution Quality Manual
- EU Directive 2001/83/ec (article 84)
- Guidelines on Good Distribution Practice of Medicinal Products for Human Use (2013/C 343/01)
- WHO Technical Report Series, No. 961, 2011, Annex 9 Model guidance for the storage and transport of time- and temperature-sensitive pharmaceutical products
- Medical Device Directive 93/42/EEC
- The relevant Marketing Authorization
- FDA Code of Federal Regulations 21 Part 820
- FDA Code of Federal Regulations 21 Part 210, 211

Therefore, ensuring that the Contract Acceptor is compliant to the Contract Giver’s requirements without the need for the Contract Acceptor to have knowledge of or access to these documents.

This Agreement covers all transportation related activities undertaken by the Contract Acceptor pursuant to the Freight Agreement with respect to the Products. The details of the transportation related activities such as pick-up location and destination are communicated to the Contract Acceptor through the detailed work order.

#### 4. PRINCIPLES

The parties acknowledge that the following key principles are agreed and are to be observed by both parties in accordance with the regulations and legislations set out in clause 1 above.

Transportation	Products are transported in a manner that does not adversely affect their safety or quality and in accordance with the requirements of the Marketing Authorisations as communicated by RB to CA.  <b>Note:</b> Specific temperature conditions are for medicinal products only. For all the other products (cosmetics, medical devices, etc.) the rule “store in ambient dry conditions, away from sources of light and heat” applies.
	Products should be handled and transported in such a way as to comply with GDP principles in particular to ensure that: a) Their identity is not lost b) They do not contaminate, and are not contaminated by, other products or materials c) Adequate precautions are taken against spillages, breakage and theft d) They are secure and not subjected to unacceptable levels of heat, cold, light, moisture or other adverse influences e.g. attack by micro-organisms or pests.
	Transportation is by pre-agreed routes and modes of transport within a defined timeframe. Any changes to pre-agreed routes or modes of transportation shall be communicated to the other party.
	Vehicles and containers provided are fit for purpose, undamaged, clean, dry and odour free. Contamination from other products shall be avoided.
	For ocean freight, the container used must meet the following specification: -40’R, 40’HR, 20R’ -Temperature and Humidity controlled vehicle with recording devices -Fabric – no wooden interiors (floors etc) -Good condition free of debris and odour
	Subject to booking and information provided to Provider: - Setpoint for controlled temperature conditions for transport at 15-25°C: temperature 18±2°C -Setpoint for humidity < 65% RH - activation of dehumidification mode
	Container security seals and tags shall be applied in accordance with local procedures one to each opening door



	Temperature control and dehumidification mode must be active throughout the end to end transport chain until the point where the product is unloaded. In case of cross-docking, Temperature control and dehumidification mode must be active during all transportation segments and in the cross-docking facility
	Measures are taken to avoid condensation to the extent possible.
	Dedicated vehicles or containers for the transportation of the Products only and no other products. Non- dedicated vehicles may only be used with the explicit, written agreement of RB.
	Products/materials are transported and stored according to written instructions. For some Products special conditions will be specified by RB.
	Products, during transportation or storage, shall not be combined with, livestock, flammables, poisons, pesticides, animal feedstuff, perishables or odorous materials.
	Products are handled and stored in such a way as to protect them from adverse weather conditions.
<b>Documentation/Communication</b>	Written procedures shall be implemented to describe the operations that may affect the quality of the product/material during the distribution activity.
	Ensure that for any sub-contracting of the transportation activities undertaken by the CA a documented Vendor Qualification Process is followed and the conditions as set out in this agreement are respected.
	Contact lists are maintained and controlled to ensure both parties know who and how to contact the other at all times.
<b>Deviations</b>	Deviations from agreed procedures that could adversely affect the safety or quality of the product/material or the accuracy of documentation shall be immediately reported to the appropriate RB contact.
<b>Change Control</b>	No changes (that may affect the safety, quality or security of the product) can be made without the prior written agreement of both RB and CA.
<b>Personnel</b>	All personnel involved in the loading and transportation of RB products/materials are trained and competent to do so. Training records are generated and readily available for inspection during on-site audits and Health Authority Inspections

## 6. RESPONSIBILITY

Each party shall be responsible for various activities relating to the technical and quality matters associated with the storage and transportation of the Products as further set out below, and Carrier shall adhere to the requirements of Contract Acceptor below:

### **If handling Canadian Shipments:**

It is the responsibility of both Reckitt Benckiser (Canada) Inc. and Carrier to ensure that all activities related to the transportation-related services provided for the transport of Health Canada regulated products are in compliance with the Canadian Good Manufacturing Practices (Division 2 of the Food and Drug Regulations and Part 3 of the Natural Health Products Regulations) and any other associated Health Canada guidance documents.

Transportation-related services may include but are not limited to the following:

- **Heated Service** (November – April or during unseasonably cold weather ) – freight must be kept at a temperature above freezing
- **Ambient Service** – freight that must be transported at 15-25°C.
- **Controlled Storage Conditions Service** – specific conditions that need to be maintained during transit (e.g. humidity, temperature, light).

Carrier shall adhere to the required applicable transportation-related services as indicated on the Bill of Lading and/or other supporting documentation. In the event that the required service cannot or has not been provided, notify Broker and Reckitt Benckiser (Canada) Inc. immediately. Carrier may be requested to assist in the investigation and deal with any violations related to services that were not rendered.

Carrier shall provide transportation-related services that prevent damage and/or cross-contamination to the Health Canada regulated products. The integrity and quality of the Health Canada regulated products must be maintained during transport. Adequate precautions must be taken against spillage and breakage. Damages, other events or problems must be reported to Broker and Reckitt Benckiser (Canada) Inc. immediately and appropriate measures taken.

Vehicles and equipment used by Carriers to transport and handle Health Canada regulated products must be:

- Suitable for use and prevent exposure to conditions that may adversely affect the quality or integrity and prevent contamination of any kind.
- Kept clean, dry and free from accumulated waste.
- Appropriately maintained.
- Kept free from rodents, vermin, birds and other pests. Cleaning and fumigation agents must not adversely affect the product quality and integrity.
- Of sufficient capacity to allow orderly storage during transport

Where special transport and storage conditions are required for the Health Canada regulated products (e.g. temperature, humidity) during transport, monitoring devices and/or records must be available and provided to Reckitt Benckiser (Canada) Inc. upon request.

Equipment used for monitoring transportation conditions of the Health Canada regulated products must be calibrated. Calibration records must be available and provided to Reckitt Benckiser (Canada) Inc. upon request.

Measures must be in place to prevent unauthorized persons from entering and/or tampering with vehicles and/or equipment transporting or handling the Health Canada regulated products, as well prevent the theft or misappropriation thereof.

## RECKITT CARGO SECURITY AND COMMUNICATION PLAN

### A. Purpose

The purpose of this procedure is to ensure the safeguarding of all Reckitt Benckiser (Reckitt) cargo that is transported between Reckitt, Reckitt Third Party Manufacturers (TPM), Reckitt Logistic Centers (LCs), Reckitt Third Party LCs and Reckitt customer's facilities as well as to assure proper communication in the event of any transportation anomaly such as lost or stolen cargo, accidents, driver related health events and mechanical problems to the tractor and/or trailer.

### B. Scope

This SOP is applicable to all North America Reckitt Supply Services elements.

### C. General Carrier and Driver Requirements

- The scheduling information of all Reckitt shipments is to be protected, and should only be communicated to the minimum number of individuals necessary to successfully complete each shipment process.
- As appropriate, each driver shall sign the "Load at Rest" document and use interstate highways and/or the most direct route when moving Reckitt freight. **At no time shall a driver take a load home.** Driver shall not leave the most direct route unless a force majeure event, traffic delays/ construction or unless preauthorized by Reckitt official identified within this document.
- Reckitt shipments shall not be dropped in an unsecured yard, left unprotected or left unattended. Minimum and preferred acceptable drop yard requirements are appended to this document.
- In addition to drop yard requirements, and whenever possible, staged trailers should be fitted with security devices that will delay unauthorized removal (i.e. king-pin and/ or glad-hand locks).
- Carrier shall develop and maintain a written security plan which shall be made available to Reckitt.
- Carrier may not sub-contract or broker a load without the express permission of Broker/Reckitt.
- Carrier may not modify the transportation modality of any Reckitt load without the permission of Broker/Reckitt.
- In accordance with Federal Motor Carrier Safety Administration (FMCSA), the Carrier shall conduct background checks for all new hires to include state, local and federal criminal history checks along with a drug screening.
- All approved Carrier drivers must be able to produce, upon demand of a designated or contracted Reckitt Security official, a driver's license, passport, TWIC Card, or other government (state) issued photographic form of identification.
- Carrier is required to ensure trailers are dry and are free of debris, dust, dirt, trash, odors, grease, rodents, insects (including, but not limited to Psocids), and pests of any kind. Food Grade Trailer means a trailer that is not contaminated, nor has the potential to have been contaminated, by the prior use of the trailer for transportation of toxic chemicals, including, but not limited to, pesticides, rodenticides, insecticides and/or other hazardous materials, substances or chemicals, and has not otherwise been used for transportation or been in close proximity of any liquid or solid waste or garbage or any like material. RB products shall not be commingled with toxic chemicals, including pesticides, rodenticides, insecticides and /or any other hazardous materials, substances or chemicals at any time prior to transport.
- Whenever possible, tractors should be equipped with satellite and/or cellular tracking technology.
- Drivers are encouraged to keep both tractor and trailer keys in a secured area and not in the cab of the vehicle.
- Should a theft occur, Reckitt reserves the right to conduct its own investigation into any significant loss or hijacking which includes, but is not limited to, interviewing all individuals who may have been associated with the shipments in question. The Carrier will be required to share any of their investigative findings with Reckitt Corporate Security.
- Full truckload trailers are to remain sealed at all times and the driver cannot break the seal unless directed by law enforcement or a Broker/Reckitt official. Broker will be notified whenever a seal is broken in transit. Carrier agrees that if a seal is broken and an inspection made by an agent of the government, its operator or other representative will take all reasonable steps to secure the count, safety, and integrity of the shipment. These steps will include requesting that the governmental entity reseal the trailer and/or make appropriate notation of the freight documentation form. Reckitt shall have the sole discretion to determine if a load or portion of a load is deemed to be unusable if the seal on such load is missing, broken, or appears to have been tampered with. If Reckitt, in its sole

discretion, determines that a load is unusable because the seal is broken or has been tampered with, Carrier shall be liable.

- If there is a claim, Reckitt will take custody of the product and Carrier is not entitled to ownership.

**D. Reporting of Lost Cargo, Mechanical Malfunction, Accident or any Event Which Could Affect Delivery Status**

- In the event of a theft, mechanical malfunction, accident or any event which adversely affects the driver, Contractor, the driver and/or carrier dispatch must immediately notify Broker. All available documents including, but not limited to, police reports, bills of lading, and carrier pro numbers shall be forwarded to Broker as soon as possible.
- Immediately upon discovery of a stolen trailer, the driver will contact law enforcement immediately as well as the Carrier's management to begin the investigation. **Notification of lost/stolen cargo must be communicated immediately upon discovery to Broker.**
- Upon notification and within 3 hours of notification of a stolen load, a written communication must be sent to Broker.
- Providing details and circumstances surrounding the stolen load. ***At a minimum, this communication will contain the following information:***
  - Confirmation that the Broker has been notified.
  - The date, time and location of the theft.
  - The name and contact information for the law enforcement agency that the theft was reported to.
  - All details regarding the load, including:
    - The date the load departed the Reckitt Logistic Center, where the load was destined to and when the load was scheduled for delivery
    - Tractor number and license plate number
    - Trailer License plate number and the trailer number
    - The shipping date, cost and HAZMAT status of the load.
    - The Bill of Lading number.
    - The seal number for the load.
  - If the trailer and/or load has been recovered, the following details will be provided:
    - The time, date and location of where the trailer/load was recovered.
    - Who and how the load was recovered. If recovered by law enforcement, it is imperative that the contact information for the law enforcement agency be provided.
    - If the seal on the trailer has been removed/cut.
  - After the load has been recovered the Contractor will contact Broker to determine if and when and where the product should be returned to Reckitt control.

**E. Procedure**

**Task 1. Protection of Cargo by Using Seals**

The Carrier must notify Broker, who will notify Reckitt, when an existing seal has to be broken (DOT), and a different seal must be applied.</li> <li>• Whenever inbound shipments and Customer shipments are received with a missing or broken seal, the product will be immediately quarantined until further notice. The Carrier must cease any future deliveries until that matter has been resolved. Notification will be sent to the Broker. Results of the investigation will dictate disposition of the shipment.</li> </ul>

## DROP LOT SECURITY REQUIREMENTS

1. Preferred: Complete perimeter fencing. Here is the definition of what constitutes a secure fence: "Chain-link fencing should be at least 6 feet in height, excluding the top rail. This fencing should be at least 9-gauge or heavier wire. This fencing should be galvanized with mesh openings not larger than 2 inches per side and have twisted selvages at the top and bottom. The wire must be taut and securely fastened to rigid metal or reinforced-concrete posts set in concrete. These posts should be evenly spaced so as to maintain fence tautness and strength. The top and bottom of the fence should contain a tension wire that runs horizontally along the entire fence line to help retain the integrity of the fence. The fencing must reach within 1 inch of hard ground or pavement. On soft ground it must reach below the surface deep enough to compensate for shifting soil or sand. This fencing should include a "top-guard" which is constructed of at least three strands of barbed wire placed at a 45 degree overhang that faces away from the property."  
Mandatory: Complete perimeter fencing/wall at least 6 feet tall and clear of foliage/debris.
2. Preferred: Security lighting that meets internationally accepted standards for security lighting. For a drop lot, (and similar to Kenco-Zeeland), this would mean 20 Lux (or, 2FC) on average, where trailers are stored  
Mandatory: Security lighting such that entrances and parking areas are well lit, providing ample lighting for support good CCTV camera images.
3. Preferred: Gated entrance wherein the gate remains closed and is manned 24x7 by a security officer. The security officer must have the ability, either via telephone or an alarm system, to signal for law enforcement support if necessary.  
Mandatory: Gated entrance wherein the gate is closed and locked outside of normal operating hours. Carrier is responsible for ensuring that the yard is patrolled by a security firm at least once every 8 hours and wherein procedures have been put into place to alert authorities whenever a breach of the perimeter is suspected to have occurred.
4. Preferred: CCTV surveillance. Lots would have to have complete CCTV coverage of the lot, equipped with color cameras with day/night capabilities. In addition, images for these cameras would need to be stored for at least 30 days. Images would need to be recorded at no less than 10 frames/second. Lastly, there must be a camera at the entrance which is capable of capturing images of the tractor and trailer, to include license plate and trailer nomenclature.  
Mandatory: CCTV surveillance of the area where trailers are parked, with images kept for a period of at least 30 days.
5. Preferred: Guard post orders would have to be established such that the security officer received clear instructions that only tractors/trailers would be allowed access to the lot and that under no circumstances would privately owned vehicles be allowed within the lot.  
Mandatory: Location MUST have a person identified as being responsible for security related matters who can be contacted 24 x 7
6. Preferred: Inbound and outbound procedures such that trailers could never be dropped or picked up without advance notification and authorization by Reckitt or Uber Freight US.  
Mandatory: Drivers required to notify their dispatch whenever they depart the drop facility.

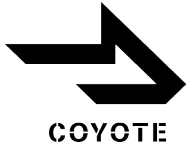
## Cargo Theft Prevention Best Practices - *A LOAD at REST is a LOAD at RISK*

Mead Johnson Nutrition/Reckitt products have been subject to incidents of theft, specifically from truck stops and other unsecured locations. As a partner and transporter of our products, we ask for your cooperation to guard against theft.

- 1) Carrier equipment will have a GPS tracking device or equivalent on either the tractor or trailer with the capability of defining its location in the event of a theft.
- 2) Drive a minimum 250 miles from point of origin prior to stopping, as permitted by applicable laws and regulations.

- 3) Your movements are being monitored by MJ/RB's GPS partner, so when stopped, take extra precautions to guard against theft:
  - a. Park in a well- lit, secured lot with CCTV (Closed-Circuit Television), where possible.
  - b. Keep your load in your line of sight when possible and carefully monitor it for suspicious activity.
  - c. Never take a load home or leave it in an unsecured lot.
  - d. If you are involved in an accident, never leave the load unattended unless emergency services are necessary.
- 4) Be alert and look out for any suspicious vehicles that may be following you. If you believe you are being followed, contact local law enforcement authorities, your dispatcher, and MJN Security Center (812-429-7500) immediately.
- 5.) Use interstate highways and/or most direct route.
  - 6) In the event of theft, contact local law enforcement authorities immediately and indicate your cargo has been stolen. Contact your dispatcher, provide details of the event and then contact main Mead Johnson Nutrition contacts. MJN Security Center (812)-429-7500
  - 7) All truckload shipments should be sealed, und remain sealed until arriving at destination where consignee should break the seal.

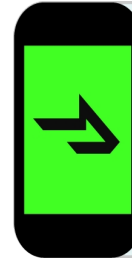

CARRIER must include signed copy of the shipper's bill of lading and any other proof of delivery with invoice to BROKER. Rates, except as specifically designated above, are inclusive of any fuel surcharge. CARRIER certifies that it is in compliance with all requirements of the California Air Resources Board (CARB) that are applicable to the scope of CARRIER's operations, including, but not limited to: Statewide Truck and Bus Regulations, Transport Refrigeration Unit (TRU) Regulations, Tractor-Trailer Greenhouse (GHG) Gas Regulations, and Drayage Truck Regulations. CARRIER hereby confirms that it maintains applicable and valid insurance without exclusions that would prevent coverage for the items listed above. CARRIER further confirms that in transporting the shipment described hereinabove, it will comply with all U.S. DOT and FDA regulations applicable to its operations while transporting said shipment, including, but not limited to drivers' hours of service, and the Food Safety Modernization Act (FSMA), if applicable. CARRIER agrees to the attached requirements from the shipper, if any.

### **ALL LOADS ARE SUBJECT TO ELECTRONIC TRACKING**

By accepting this shipment, CARRIER agrees that it has obtained a written agreement from each driver transporting a shipment tendered by BROKER to CARRIER pursuant to the Agreement in which each driver provides all necessary consents to (i) receiving text messages and/or phone calls from or on behalf of BROKER and (ii) allowing BROKER or its vendor to track such driver's location while transporting such shipment. CARRIER shall comply with all applicable laws relating to the collection, use, storage, retention, disclosure, and disposal of any information CARRIER provides to BROKER, including information regarding the drivers transporting shipments. CARRIER shall indemnify, defend, and hold BROKER and its affiliates harmless from and against any and all claims, damages, liabilities, losses, actions and expenses (including attorneys' fees) arising out of or in connection with CARRIER's breach of this Section. This Section shall survive the expiration or termination of the Agreement between BROKER and CARRIER.

**Carrier shall adhere to the following requirements:**

Carrier shall waive any right to salvage and any right to offset from Shipper’s claim for salvage value. Carrier shall not retain possession of any product or package that has suffered physical damage without the consent of Shipper.

Any person associated with the Carrier who is performing activities in connection with services for RB are required to abide by terms of UPS Code of Business Conduct ([https://www.ups.com/media/en/code\\_bus\\_conduct.pdf](https://www.ups.com/media/en/code_bus_conduct.pdf)).

Carrier shall have no lien, and hereby waives its right to any lien, upon any shipment or portion thereof.

**1. PURPOSE/SCOPE/LIMITATIONS**

This Agreement constitutes the quality technical agreement required for the transportation of the Contract Giver’s products as well as products of its affiliates and Contract Manufacturing Organisations categorised as Medicines and Medical Devices and materials used in the manufacture and/or packaging of the same (“Products”) and defines the Contract Giver’s and Contract Acceptor’s responsibilities. This Agreement is based on and incorporates the Contract Giver’s requirements as set in e.g.:

- The relevant Marketing Authorization

Therefore, ensuring that the Contract Acceptor is compliant to the Contract Giver’s requirements without the need for the Contract Acceptor to have knowledge of or access to these documents.

This Agreement covers all transportation related activities undertaken by the Contract Acceptor pursuant to the Freight Agreement with respect to the Products. The details of the transportation related activities such as pick-up location and destination are communicated to the Contract Acceptor through the detailed work order.

#### 4. PRINCIPLES

The parties acknowledge that the following key principles are agreed and are to be observed by both parties in accordance with the regulations and legislations set out in clause 1 above.

### **If handling Canadian Shipments:**

It is the responsibility of both Reckitt Benckiser (Canada) Inc. and Carrier to ensure that all activities related to the transportation-related services provided for the transport of Health Canada regulated products are in compliance with the Canadian Good Manufacturing Practices (Division 2 of the Food and Drug Regulations and Part 3 of the Natural Health Products Regulations) and any other associated Health Canada guidance documents.

Transportation-related services may include but are not limited to the following:

- **Heated Service** (November – April or during unseasonably cold weather ) – freight must be kept at a temperature above freezing
- **Ambient Service** – freight that must be transported at 15-25°C.
- **Controlled Storage Conditions Service** – specific conditions that need to be maintained during transit (e.g. humidity, temperature, light).

Carrier shall adhere to the required applicable transportation-related services as indicated on the Bill of Lading and/or other supporting documentation. In the event that the required service cannot or has not been provided, notify Broker and Reckitt Benckiser (Canada) Inc. immediately. Carrier may be requested to assist in the investigation and deal with any violations related to services that were not rendered.

Carrier shall provide transportation-related services that prevent damage and/or cross-contamination to the Health Canada regulated products. The integrity and quality of the Health Canada regulated products must be maintained during transport. Adequate precautions must be taken against spillage and breakage. Damages, other events or problems must be reported to Broker and Reckitt Benckiser (Canada) Inc. immediately and appropriate measures taken.

Vehicles and equipment used by Carriers to transport and handle Health Canada regulated products must be:

- Suitable for use and prevent exposure to conditions that may adversely affect the quality or integrity and prevent contamination of any kind.
- Kept clean, dry and free from accumulated waste.
- Appropriately maintained.
- Kept free from rodents, vermin, birds and other pests. Cleaning and fumigation agents must not adversely affect the product quality and integrity.
- Of sufficient capacity to allow orderly storage during transport

Where special transport and storage conditions are required for the Health Canada regulated products (e.g. temperature, humidity) during transport, monitoring devices and/or records must be available and provided to Reckitt Benckiser (Canada) Inc. upon request.

Equipment used for monitoring transportation conditions of the Health Canada regulated products must be calibrated. Calibration records must be available and provided to Reckitt Benckiser (Canada) Inc. upon request.

Measures must be in place to prevent unauthorized persons from entering and/or tampering with vehicles and/or equipment transporting or handling the Health Canada regulated products, as well prevent the theft or misappropriation thereof.



## RECKITT CARGO SECURITY AND COMMUNICATION PLAN

### A. Purpose

The purpose of this procedure is to ensure the safeguarding of all Reckitt Benckiser (Reckitt) cargo that is transported between Reckitt, Reckitt Third Party Manufacturers (TPM), Reckitt Logistic Centers (LCs), Reckitt Third Party LCs and Reckitt customer's facilities as well as to assure proper communication in the event of any transportation anomaly such as lost or stolen cargo, accidents, driver related health events and mechanical problems to the tractor and/or trailer.

### B. Scope

This SOP is applicable to all North America Reckitt Supply Services elements.

### C. General Carrier and Driver Requirements

- The scheduling information of all Reckitt shipments is to be protected, and should only be communicated to the minimum number of individuals necessary to successfully complete each shipment process.
- As appropriate, each driver shall sign the "Load at Rest" document and use interstate highways and/or the most direct route when moving Reckitt freight. **At no time shall a driver take a load home.** Driver shall not leave the most direct route unless a force majeure event, traffic delays/ construction or unless preauthorized by Reckitt official identified within this document.
- Reckitt shipments shall not be dropped in an unsecured yard, left unprotected or left unattended. Minimum and preferred acceptable drop yard requirements are appended to this document.
- In addition to drop yard requirements, and whenever possible, staged trailers should be fitted with security devices that will delay unauthorized removal (i.e. king-pin and/ or glad-hand locks).
- Carrier shall develop and maintain a written security plan which shall be made available to Reckitt.
- Carrier may not sub-contract or broker a load without the express permission of Broker/Reckitt.
- Carrier may not modify the transportation modality of any Reckitt load without the permission of Broker/Reckitt.
- In accordance with Federal Motor Carrier Safety Administration (FMCSA), the Carrier shall conduct background checks for all new hires to include state, local and federal criminal history checks along with a drug screening.
- All approved Carrier drivers must be able to produce, upon demand of a designated or contracted Reckitt Security official, a driver's license, passport, TWIC Card, or other government (state) issued photographic form of identification.
- Carrier is required to ensure trailers are dry and are free of debris, dust, dirt, trash, odors, grease, rodents, insects (including, but not limited to Psocids), and pests of any kind. Food Grade Trailer means a trailer that is not contaminated, nor has the potential to have been contaminated, by the prior use of the trailer for transportation of toxic chemicals, including, but not limited to, pesticides, rodenticides, insecticides and/or other hazardous materials, substances or chemicals, and has not otherwise been used for transportation or been in close proximity of any liquid or solid waste or garbage or any like material. RB products shall not be commingled with toxic chemicals, including pesticides, rodenticides, insecticides and /or any other hazardous materials, substances or chemicals at any time prior to transport.
- Whenever possible, tractors should be equipped with satellite and/or cellular tracking technology.
- Drivers are encouraged to keep both tractor and trailer keys in a secured area and not in the cab of the vehicle.
- Should a theft occur, Reckitt reserves the right to conduct its own investigation into any significant loss or hijacking which includes, but is not limited to, interviewing all individuals who may have been associated with the shipments in question. The Carrier will be required to share any of their investigative findings with Reckitt Corporate Security.
- Full truckload trailers are to remain sealed at all times and the driver cannot break the seal unless directed by law enforcement or a Broker/Reckitt official. Broker will be notified whenever a seal is broken in transit. Carrier agrees that if a seal is broken and an inspection made by an agent of the government, its operator or other representative will take all reasonable steps to secure the count, safety, and integrity of the shipment. These steps will include requesting that the governmental entity reseal the trailer and/or make appropriate notation of the freight documentation form. Reckitt shall have the sole discretion to determine if a load or portion of a load is deemed to be unusable if the seal on such load is missing, broken, or appears to have been tampered with. If Reckitt, in its sole

discretion, determines that a load is unusable because the seal is broken or has been tampered with, Carrier shall be liable.

- If there is a claim, Reckitt will take custody of the product and Carrier is not entitled to ownership.

**D. Reporting of Lost Cargo, Mechanical Malfunction, Accident or any Event Which Could Affect Delivery Status**

- In the event of a theft, mechanical malfunction, accident or any event which adversely affects the driver, Contractor, the driver and/or carrier dispatch must immediately notify Broker. All available documents including, but not limited to, police reports, bills of lading, and carrier pro numbers shall be forwarded to Broker as soon as possible.
- Immediately upon discovery of a stolen trailer, the driver will contact law enforcement immediately as well as the Carrier's management to begin the investigation. **Notification of lost/stolen cargo must be communicated immediately upon discovery to Broker.**
- Upon notification and within 3 hours of notification of a stolen load, a written communication must be sent to Broker.
- Providing details and circumstances surrounding the stolen load. ***At a minimum, this communication will contain the following information:***
  - Confirmation that the Broker has been notified.
  - The date, time and location of the theft.
  - The name and contact information for the law enforcement agency that the theft was reported to.
  - All details regarding the load, including:
    - The date the load departed the Reckitt Logistic Center, where the load was destined to and when the load was scheduled for delivery
    - Tractor number and license plate number
    - Trailer License plate number and the trailer number
    - The shipping date, cost and HAZMAT status of the load.
    - The Bill of Lading number.
    - The seal number for the load.
  - If the trailer and/or load has been recovered, the following details will be provided:
    - The time, date and location of where the trailer/load was recovered.
    - Who and how the load was recovered. If recovered by law enforcement, it is imperative that the contact information for the law enforcement agency be provided.
    - If the seal on the trailer has been removed/cut.
  - After the load has been recovered the Contractor will contact Broker to determine if and when and where the product should be returned to Reckitt control.

**E. Procedure**

**Task 1. Protection of Cargo by Using Seals**

## DROP LOT SECURITY REQUIREMENTS

1. Preferred: Complete perimeter fencing. Here is the definition of what constitutes a secure fence: "Chain-link fencing should be at least 6 feet in height, excluding the top rail. This fencing should be at least 9-gauge or heavier wire. This fencing should be galvanized with mesh openings not larger than 2 inches per side and have twisted selvages at the top and bottom. The wire must be taut and securely fastened to rigid metal or reinforced-concrete posts set in concrete. These posts should be evenly spaced so as to maintain fence tautness and strength. The top and bottom of the fence should contain a tension wire that runs horizontally along the entire fence line to help retain the integrity of the fence. The fencing must reach within 1 inch of hard ground or pavement. On soft ground it must reach below the surface deep enough to compensate for shifting soil or sand. This fencing should include a "top-guard" which is constructed of at least three strands of barbed wire placed at a 45 degree overhang that faces away from the property."  
Mandatory: Complete perimeter fencing/wall at least 6 feet tall and clear of foliage/debris.
2. Preferred: Security lighting that meets internationally accepted standards for security lighting. For a drop lot, (and similar to Kenco-Zeeland), this would mean 20 Lux (or, 2FC) on average, where trailers are stored  
Mandatory: Security lighting such that entrances and parking areas are well lit, providing ample lighting for support good CCTV camera images.
3. Preferred: Gated entrance wherein the gate remains closed and is manned 24x7 by a security officer. The security officer must have the ability, either via telephone or an alarm system, to signal for law enforcement support if necessary.  
Mandatory: Gated entrance wherein the gate is closed and locked outside of normal operating hours. Carrier is responsible for ensuring that the yard is patrolled by a security firm at least once every 8 hours and wherein procedures have been put into place to alert authorities whenever a breach of the perimeter is suspected to have occurred.
4. Preferred: CCTV surveillance. Lots would have to have complete CCTV coverage of the lot, equipped with color cameras with day/night capabilities. In addition, images for these cameras would need to be stored for at least 30 days. Images would need to be recorded at no less than 10 frames/second. Lastly, there must be a camera at the entrance which is capable of capturing images of the tractor and trailer, to include license plate and trailer nomenclature.  
Mandatory: CCTV surveillance of the area where trailers are parked, with images kept for a period of at least 30 days.
5. Preferred: Guard post orders would have to be established such that the security officer received clear instructions that only tractors/trailers would be allowed access to the lot and that under no circumstances would privately owned vehicles be allowed within the lot.  
Mandatory: Location MUST have a person identified as being responsible for security related matters who can be contacted 24 x 7
6. Preferred: Inbound and outbound procedures such that trailers could never be dropped or picked up without advance notification and authorization by Reckitt or Uber Freight US.  
Mandatory: Drivers required to notify their dispatch whenever they depart the drop facility.

## Cargo Theft Prevention Best Practices - *A LOAD at REST is a LOAD at RISK*

Mead Johnson Nutrition/Reckitt products have been subject to incidents of theft, specifically from truck stops and other unsecured locations. As a partner and transporter of our products, we ask for your cooperation to guard against theft.

- 1) Carrier equipment will have a GPS tracking device or equivalent on either the tractor or trailer with the capability of defining its location in the event of a theft.
- 2) Drive a minimum 250 miles from point of origin prior to stopping, as permitted by applicable laws and regulations.

- 3) Your movements are being monitored by MJ/RB's GPS partner, so when stopped, take extra precautions to guard against theft:
  - a. Park in a well- lit, secured lot with CCTV (Closed-Circuit Television), where possible.
  - b. Keep your load in your line of sight when possible and carefully monitor it for suspicious activity.
  - c. Never take a load home or leave it in an unsecured lot.

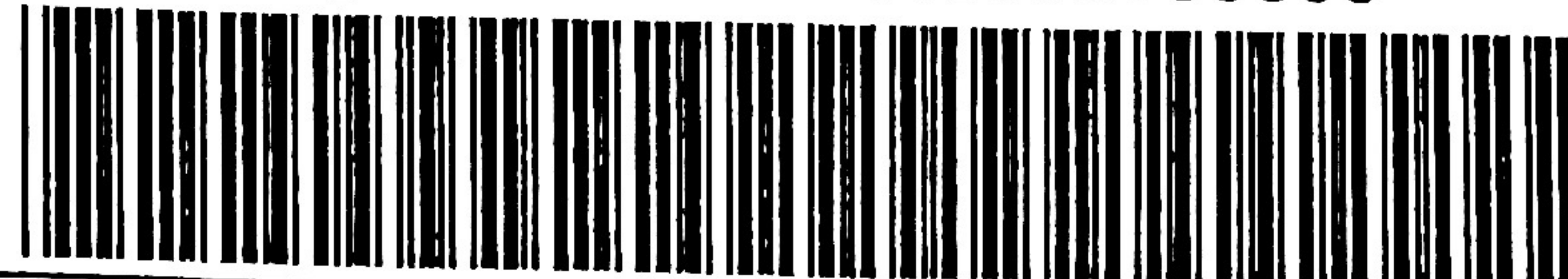


