## Rate Confirmation Agreement for The Roots Logistics LLC

- The safe, legal, and proper operation of Carrier and its driver supersedes any request, demand,
  preference, instruction, or information provided by Broker or its customers with respect to any shipment.
  If any employee of Broker or its customer requests, demands, or instructs carrier to take any action that
  violate any law, whether deliberate or unintended, Carrier shall refuse to transport that load and
  promptly contact the Broker before taking any further action.
- This document can be used as a substitute for an invoice. If there are objections to the terms stated they must be submitted within 24 hours after receipt.
- Rate shown includes any applicable fuel surcharges, pickup and delivery charges, loading and unloading, out of route, detention, storage, and/or all arbitrary charges etc. Deviation from these rates must be approved in writing and signed by both parties.
- Any authorized unloading will only be reimbursed with a valid unloading receipt.
- Check calls must be made daily by 9 am EST or carrier will be charged a penalty fee of \$100 per day.
- If pickup or delivery times are missed without prior notification to The Roots Logistics LLC, carrier will be subject to penalty charges of \$100 per day. Additional late delivery charges assessed by the consignee may also apply.
- In order to collect detention carrier must notify **The Roots Logistics LLC**, within 2 hours after appointment time of any delays. Late pick-ups or late deliveries are not eligible for detention charges. If facility is FCFS, detention will only be paid if carrier is loaded or unloaded outside of the regular pick-up or delivery hours. If applicable, the arrival and departure times must be stamped and/or written on the BOL.
- All refrigerated loads must be run on continuous unless otherwise stated.
- Driver is responsible for all load counts. If driver is not granted access to the loading dock they must call
  the broker to notify immediately.
- Driver must pulp product before leaving shipper.
- Any navigational directions given to the carrier or its drivers are for informational purposes only, carrier
  and its drivers shall have no obligation to follow such navigational directions.
- Carrier acknowledges that they are solely responsible for compliance with all applicable HOS regulations, as well as all other FMCSA regulations.
- Carrier agrees to have a minimum of \$100,000 in cargo liability insurance and \$1,000,000 auto liability insurance in place and effective as of the ship date and fully effective until load is delivered.
- No drivers are authorized to break seals under any circumstances. Seals must only be broken by the
  consignee's personnel. Loads delivered without the seals intact will result in fines and potential claims.
