- 3. SAFE agrees to pay within 30 days of receipt of carrier invoice and signed original BOL. If a lumper is required, the carrier must pay it and SAFE will reimburse the cost. Lumper receipts must be submitted at time of original invoice.
- 4. NO DOUBLE BROKERING. Payment will not be made if freight is double brokered, subcontracted, interlined or otherwise assigned. Carrier must handle this load under their own authority.
