

Driver Instructions: BY APPOINTMENT PPE required on site. Failure to slide tandems all the way back before dropping trailer will result in \$30 tandem slide fee. Drivers must notify Arrive once they have checked in on site. Notify Arrive if drivers are sent to overflow lot to await loading. If drivers are sent to overflow, they are NOT queued for loading. All drivers MUST give the following information to truck gate: - Name of the broker they are hauling for (ARVY) - Shipment number - City/state of destination. - Valid physical drivers license. - Trailers Must Be Food Grade - Auto-tracking required Trenton will reject any driver that does not have all 4 required pieces of information/documents. Drivers are required to secure shipments with minimum 2 locks/straps BEFORE they proceed to the Outbound scale. Loads will be scaled and sealed at the outbound gate, so drivers must inspect and install securement prior to proceeding to the scale. Driver checks the shipment prior to leaving the yard to ensure secured and loaded properly. Once driver departs the yard, the driver assumes all responsibility for the load. Driver must notify Arrive before leaving the shipper if they have any issues securing or inspecting the load. Driver must get proof of securement before departing the shipper. Reworks are the carrier's responsibility. NO TRI-AXLE TRAILERS-Shipper does NOT load to scale. Drivers must be physically checked in on site properly by their appointment time to be eligible for detention, layover, or TONU. If a driver leaves and returns after the appointment time, they will be considered a work in to be loaded. Work-ins are not eligible for detention/layover/TONU. Carriers must advise Arrive AT THE TIME OF OCCURRENCE if drivers are notified at shipper of any delays on production in order to be eligible for detention/layover/TONU.

All trailers must be absolutely free of all debris of any kind or will be turned away and refused loading. Reasons to reject trailer at loading include, but are not limited to the following: Foul Odors, Broken glass, Metal shavings, Infestation, and mold.

Load locks or 2 straps or a combination of these two options - Mandatory for each load. Drivers will be turned away if noncompliant.

All drivers must arrive 15 minutes prior to their scheduled pick up time at this location. You will be considered late if you arrive less than 15 minutes prior to your pickup appointment.

Drivers must confirm trailer seal on correct trailer door prior to departure

### **Operational Rules:**

1. If a driver is not permitted to confirm (by visual inspection) that the load is secure and the piece count is correct.

The driver is required to call Arrive immediately and have this information documented on the BOL with the words - Shipper Load/Count per Shipper Signature / Initials.

### Communication to Arrive must take place PRIOR to the driver leaving the facility.

- 2. Do not dispatch a driver who cannot meet transit time without violating Hours of Service or other safety rules. Nothing in this Rate Confirmation constitutes a request to violate Hours of Service or other safety rules or to coerce a driver to do so.
- 3. This Rate Confirmation is deemed accepted by Carrier unless it is rejected within 48 hours of receipt.
- 4. Receipt of shipment by Carrier constitutes acceptance of and agreement to the terms of this Rate Confirmation.
- 5. Double brokering without prior written authorization will result in forfeiture of payment by Arrive to Carrier.
- 6. Any communication regarding this load must be addressed to Arrive and not its customer.
- 7. All charges are included in this Rate Confirmation.
- 8. Carrier must give Arrive notice 1 Hour prior to detention occurring.
- 9. Carrier agrees in the event there are overages, shortages, or damages, Carrier will contact Arrive's office to report the discrepancy before leaving the customer's premises.
- 10. Payment will be made within thirty (30) days after receipt of invoice, original BOL, and signed Load-Rate Confirmation unless Arrive disputes the invoice or any part thereof.
- 11. Freight must not be handled, railed, shipped by intermodal means, or transloaded by Carrier without prior approval from Arrive. In the event of Carrier's violation of this Operational Rule, the limitation of liability as to cargo loss or damage set forth in the Broker Carrier Agreement between Arrive and Carrier shall be voided and payment by Arrive to Carrier shall be forfeited by Carrier in full.
- 12. Carrier or its agent certifies that any Transportation Refrigeration Unit (TRU or reefer) equipment furnished will be in compliance with the in-use requirements of the California TRU regulations.
- 13. This Rate Confirmation incorporates the terms and conditions of a Broker Carrier Agreement signed by Arrive and Carrier.
- 14. In the event of a conflict between this Rate Confirmation and any Broker Carrier Agreement between Arrive and Carrier, this Load-Rate Confirmation shall govern as to the provisions in conflict.
