TERMS AND CONDITIONS

The following terms and conditions apply to the services to be performed by the motor carrier identified on the Rate Confirmation ("Carrier") pursuant to this Rate Confirmation:

This Rate Confirmation is subject to the terms and conditions of the BWS Broker/Carrier Agreement ("BCA") in place between BWS and Carrier. Absent a current BCA, this Rate Confirmation is subject to the terms and conditions agreed upon in writing by BWS and Carrier ("Carrier Terms"). Notwithstanding anything to the contrary in the Carrier Terms, these terms and conditions shall supersede the Carrier Terms and apply to the shipment identified in the Rate Confirmation.

Carrier must initiate and maintain Macropoint/ELD tracking for the entirety of the shipment, failure to initiate and maintain tracking will result in a rate reduction of \$50 per day.

When required by BWS per the Rate Confirmation, the Carrier's driver must send a picture of the loaded secured freight, DO and confirmation of piece count prior to leaving shipper and POD with receivers name printed, signed and dated prior to leaving. Failure to provide the picture will result in a rate reduction as provided in the Rate Confirmation.

Unless stated otherwise in the Rate Confirmation, all loads are to be hauled by Carrier using a dedicated trailer.

BWS pays detention after two (2) free hours of loading and unloading time following the scheduled appointment unless stated otherwise on this Rate Confirmation. Carrier must notify BWS prior to entering detention or layover. Signed in and out times must be listed on the BOL in order to be eligible for detention. Driver/Dispatch has 24hrs to submit signed in and out time on BOL from when detention occurred in order to be paid.

Carrier must notify the broker immediately of any and all paperwork discrepancies. Any discrepancies between this Rate Confirmation and the BOL must be brought to the attention of BWS and written clarification must be provided prior to departing the origin location.

Carrier agrees to provide immediate updates in regards to any delays or breakdowns.

Re-Brokering or outsourcing to a driver and/or tractor that is not covered under the MC/Carrier's Insurance belonging to the carrier named on the Rate Confirmation will allow BWS to make payment directly to such performing driver and result in forfeiture of payment obligation to the carrier unless written consent from BWS is provided.

As provided in the Rate Confirmation, certain shipments moved for BWS are time sensitive and, unless stated otherwise, all loads are to be hauled using a dedicated trailer (collectively, "Expedited Shipments"). Expedited Shipments must be delivered on the delivery dates and times referenced on this Rate Confirmation. Expedited Shipments that do not meet the set date, time, or exclusivity requirement criteria, will be subject to a rate reduction of 10% or, as provided in the Rate Confirmation, subjected to fines on a pass-through basis .

Unless otherwise agreed in writing by BWS in the BCA or Carrier Terms, BWS shall pay Carrier invoices within thirty (30) days of Broker's receipt of Carrier's uncontested invoice and all relevant shipping documentation. For prompt payment, Carrier should attach the signed POD, BWS Rate Confirmation, and Carrier invoice showing BWS reference number.

The signing of the Rate Confirmation, the individual signing represents and warrants: (i) they are an authorized representative of Carrier and can bind Carrier to this Rate Confirmation; (ii) the Rate Confirmation is an agreement between Carrier and BWS for Carrier to transport the above described shipment for the rate and charges as shown above; and (iii) Carrier agrees to these Rate Confirmation Terms and Conditions.
