D&L CARLISLE & SONS INC - UHAUPHA1: All U-Boxes included in this shipment must pick up and a BOL must be sent by the latest pickup date displayed on this Rate Confirmation, or carrier may be subject to U-Haul's late pick-up fee being passed through of up to \$200.
