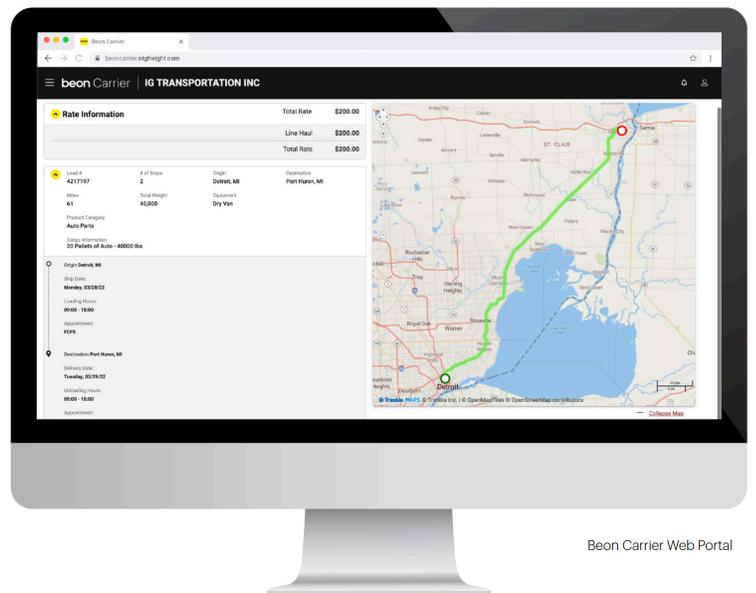

## **NTG Accessorial Charges for Chep Pallets**

This document signifies the maximum amount NTG will pay for the specified accessorial charges.

### **TONU (Truck Order Not Used) - \$150/per shipment**

- Email notification to broker/broker's team at the time of cancellation or driver arrival is required
- TONU claims must be submitted within 24 hours via email. Driver must already be dispatched to the load when it is cancelled. Dispatches more than 6 hours prior to a pickup where a TONU is requested will require documentation around driver position.

### **Layover**

- \$150/day

### **Detention (Power unit) - \$40/hour after 2 hours**

- Requires notification to broker/broker's team of potential detention .5 hours prior to the end of free time
- If no notification occurs, NTG is not liable for any subsequent detention charges.

### **Detention (Drop Trailer) - \$50/day after 48 hours past day of drop, not including weekends and holidays**

- \$50/day after expiration of free time
- Maximum Charge of \$350.00 per month per trailer
- Applies to shipper facilities only, excludes Walmart
- Requires notification to broker/broker's team of potential detention 6 hours prior to the end of free time
  - o If no notification occurs, NTG is not liable for any subsequent detention charges
  - o On-time arrival and proof of on-time arrival required

### **Reconsignment, Diversion, Returned, Undelivered**

- \$150.00 flat fee + \$1.18/mile + applicable FSC

### **Redelivery**

- \$1.18/mile + applicable FSC subject to a minimum charge of \$150.00 per shipment when redelivery is required through no fault of carrier. Requires notification to broker/broker's team prior to redelivery.
- If no notification occurs, NTG is not liable for any redelivery charges

### **Stops In Transit**

- Stop 1 charge equal to \$100 and then \$50.00 for each additional charge

### **Reverse Accessorial - \$60 flat fee if equipment is contrary to tendered equipment type is used to haul load.**
