#### Border Crossing Shipment Requirements

- Any layover/detention/wait time at the border will be calculated based on when the email alerting TQL of the issue is received.







 At no time may a carrier place and/or transport a shipment under/ in-bond without prior written approval from TQL before doing so.

- In the event detention occurs, only one (1) Rate Confirmation with detention added will be sent per load, and only upon completion of the load with correct POD and BOL being submitted.
- If a "Truck Order Not Used" (TONU) is to be reviewed and paid out regarding this TQL shipment, the deadhead mileage will be calculated based off the first tracking location pinged. If tracking was never accepted, deadhead mileage will not be compensated.
- In the event additional pallets are loaded by the shipper beyond what is agreed to on the Rate Confirmation an/or Load Information Sheet, additional compensation will be limited to a maximum \$50 per extra/additional pallet that is loaded. By signing the Rate Confirmation, you are confirming that a maximum of \$50 per extra pallet is acceptable.
- Carrier must reach out to TQL for a com check on loads requiring a lumper. Carrier should NOT issue

- Failure to accept TQL tracking may result in removal from load, no TONU will be paid to carriers removed from load for failing to accept TQL's tracking request.

#### Carrier Requirements:

- · Carrier is responsible for securing, maintaining, and paying for any permits necessary to haul this load
- Driver(s) must be checked in on time for scheduled loading/unloading appointment/within FCFS loading/unloading window in order to be eligible for any accessorial pay.
- Please note that some shipping or receiving locations may require you to have a reflective vest, steel toe boots and a mask covering
- In the event you are unable to pick up this shipment please notify TQL immediately.
- Weight provided is an estimate; no additional compensation will be given for variances if load does not exceed legal limits
- Driver must verify the BOL number matches the TQL pick up number provided to them. If there are any discrepancies email <a href="mailto:akincaid@tql.com">akincaid@tql.com</a> immediately with the TQL load number and picture of the BOL.
- Failure to call TQL if/when loaded with the incorrect PO may result in non-payment of the load, a claim, or repower.
- Late pick up or delivery may result in non-payment of freight charges, and special damages as a consequence of being late may apply. This includes, but is not limited to, freight charges for expedited shipments, packaging materials, additional labor charges, storage charges, spoiled product, loss of sale, the expense of any additional equipment, service, or alternate transportation arrangements that need to be utilized as a result of late pick up or delivery.
- All "TBA/TBD" appointment times with shippers and receivers at time of carrier dispatch/booking will be scheduled based on the driver ETA to pick up or delivery provided to TQL by the carrier.
- For appointments that are already scheduled prior to booking and dispatching the carrier/driver is expected to honor and arrive at the agreed upon appointment times that were set at the time of booking/scheduling.
- For all Dry Van and Box Truck loads: under no circumstances should a driver ever leave a shipping/loading location without seal(s) and locks properly applied to the trailer handle(s)
- This shipment is required to have a signed/stamped BOL and POD by the shipper and the receiver.
- BOL's and POD's must include the following:
  - Print first and last name of person employed at the shipping and/or receiving location
  - The individual's signature
  - The date (Month/ Day/ Year)
  - Check-in time of facility
  - Check-out time of facility

#### Border Crossing Shipment Requirements





- Carrier must submit information for border crossings 24 hours in advance of border crossing attempt. Required
  information will include but is not limited to: PARS/PAPS number, Port of Entry and estimated time of crossing must
  be submitted.
- Failing to provide the necessary information to TQL may cause a delay in the customs clearance of the load and layover/detention/wait time will not be compensated for the first 24 hours of information having been received.
- All information must be relayed to TQL in writing; verbal advisement must be followed up with written documentation.
- Carrier must immediately report issues regarding customs clearances by sending an email to Akincaid@tql.com
- If a customs clearance issue is reported on a Saturday or Sunday, layover/detention/wait time will begin at 9:00am the following Monday.
- Any layover/detention/wait time at the border will be calculated based on when the email alerting TQL of the issue is received.
- At no time may a carrier place and/or transport a shipment under/ in-bond without prior written approval from TQL before doing so. If a shipment is transported under/in-bond to cross an international border without written consent from TQL, any costs associated will be denied including but not limited to: warehousing cost, trailer cost, processing cost, documentation cost, duties and tax cost, storage cost, fuel cost, labor cost.
- Clarification regarding in-bond are as follows: Product or commodity intending to move within U.S./Canada/Mexico boundaries but has not yet been processed by Customs Broker to officially enter the country.

#### Loads Attended & Recovered:

- The driver of the load is not permitted to leave the cargo unattended at any time. <u>Cargo left unattended by the driver</u>, <u>regardless of whether it is left at a secured lot</u>, warehouse, plant or parking lot is strictly forbidden.
- In the event of an emergency TQL must be notified as soon as it is safe to do so, and before the load may be left unattended
- In the event of a breakdown or any delay that jeopardizes on time delivery, TQL may request that the carrier allow a repower of their trailer to avoid/mitigate damages
- TQL will take action on unattended cargo, up to and including replacement carriers being sent to collect and complete delivery of unattended cargo; carrier will be responsible for all associated costs, including but not limited to towing fees, alternate transportation arrangements, or any additional equipment or service needed to complete delivery.

#### Accessorial Pay Requirements:

  - Times Must Also Be Written on the BOL and be signed/stamped by the facility the detention occurred at.
- In the event detention occurs, all detention payment requests need to be sent to TeamKincaidDetention@tql.com.
- In the event detention occurs, only one (1) Rate Confirmation with detention added will be sent per load, and only upon completion of the load with correct POD and BOL being submitted.
- If a "Truck Order Not Used" (TONU) is to be reviewed and paid out regarding this TQL shipment, the deadhead mileage will be calculated based off the first tracking location pinged. If tracking was never accepted, deadhead mileage will not be compensated.
- In the event additional pallets are loaded by the shipper beyond what is agreed to on the Rate Confirmation an/or Load Information Sheet, additional compensation will be limited to a maximum \$50 per extra/additional pallet that is loaded. By signing the Rate Confirmation, you are confirming that a maximum of \$50 per extra pallet is acceptable.
- Carrier must reach out to TQL for a com check on loads requiring a lumper. Carrier should NOT issue payment on their own and failure to requesting a com check may result in result in fees, delays, or other issues being assessed.
- For all shipping and receiving locations that utilize lumpers, a clear and readable picture of the lumper receipt must be submitted to AKincaid@TQL.com within 24 hours of delivery to guarantee compensation or reimbursement.
- Any lumper receipts submitted later than 24 hours post-delivery can result in denial of compensation or reimbursement of that lumper. Please ensure to promptly email a clear picture of your lumper receipt right after your delivery.

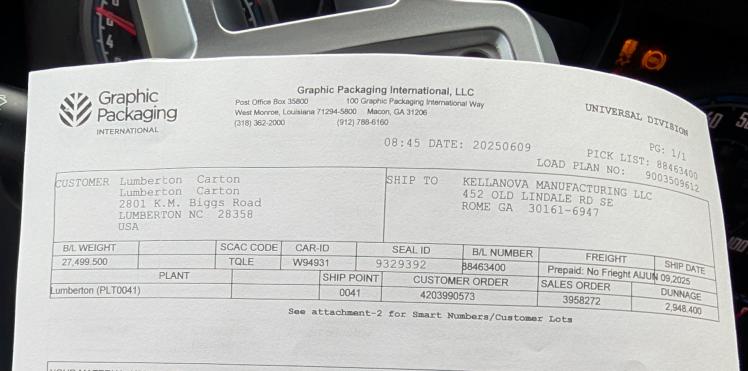

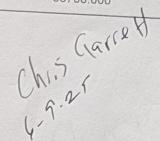

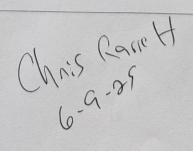
