- Detention will not be paid unless there are unforeseen circumstances and the delay has been clearly communicated with your Apollo Freight Solutions sales representative at the time of occurrence.
- A minimum \$150 late fee may be assessed if the driver fails to arrive at the shipper or receiver at the scheduled appointment time.

Notes and Terms of Carrier Responsibility-

- **Seal Integrity:** All loads must be sealed at origin by either the shipper or the driver, and the seal number must be clearly recorded on the Bill of Lading (BOL). If a shipment that was sealed at origin arrives at destination with a broken, missing, or tampered seal:
 - (i) the Carrier shall be held fully liable for any resulting shortage, contamination, or damage claims, and
 - (ii) the Shipper reserves the right to reject the shipment in full, deeming it damaged, contaminated, and unsalvageable, without the need for inspection. Carrier will be held liable for the full replacement value of the shipment.
- Carrier Conduct and Liability: Carrier is an independent contractor and not an agent of Apollo Freight Solutions LLC. Apollo Freight Solutions LLC shall not be held liable for the actions, omissions, or negligence of the Carrier or its representatives.
- Documentation Requirements: The Carrier is responsible for ensuring the BOL and/or POD is properly signed by the receiver in the designated area upon delivery. All exceptions, shortages, or damages must be clearly noted at the time of delivery. Failure to provide complete, legible, and accurate delivery documentation may result in delayed or withheld payment.
- Driver Conduct at Facilities:

Drivers must remain in their vehicle unless instructed otherwise.

Repeated requests to be loaded/unloaded are not permitted.

Drivers must follow all facility rules and respect all shipper/receiver personnel.

Equipment Requirements:

Liftgates or any equipment that blocks the loading of a full trailer are prohibited.

Conestoga trailers must be clean, dry, free of holes and debris (including glass), and remain covered until unloading unless otherwise instructed. Do not open access doors

without explicit broker approval. Follow broker instructions for sealing procedures on Conestogas.

- **Lumper Fees:** All lumper fees must be paid by the driver at the time of service. The broker will reimburse with a valid receipt.
- Tracking Compliance: Carrier must accept and comply with broker-issued tracking links (e.g., MacroPoint) or provide comparable satellite tracking. Failure to comply may result in the carrier being removed from the load and replaced.
