*For loads picking up in Milwaukee WI and South Brunswick NJ, please make sure driver brings Paper/Physical Check for Pallet Exchange; Get this free from Truckstops.

*Failure to accept MACROPOINT tracking invitation will incur \$35 PENALTY.

*Pls follow temperature listed on bills. If shipper says commodity is dry but the load required a reefer, temperature must still be set to 40F.

*If asked to pay lump sum at the receiver, tell them it's Red Dog. NO LUMPER AT THE RECEIVER. It's supposed to be prepaid.

*DRIVERS SHOULD BE PRESENT ON REINHART DOCK TO OBSERVE UNLOADING. \$100 LATE FEE if driver arrives at Reinhart past 1hr from appt time.

*Payment and/or reimbursement of accessorial may be granted (e.g. Pallet exchange fee) as long as copy of receipt is sent to Red Dog within 24hrs of pickup. No receipt would mean deduction on the rate confirmation amount.
