Notes:

- *All trailers must be Sealed any load arriving to receiver without a seal or a broken seal will be subject to rejection and/or claim

If commodity is listed as Draught Van loads must deliver within 14 hours of loading which is 4 hr preload + 10 hrs max transit

Reefer loads must maintain 38 Degrees
