Terms and Conditions of this Contract of Carriage

- 1. Carrier must issue a bill of lading prior to picking up the entrusted goods and name CAT as the load broker. He must also insert CAT's inscription number (NI) and/or operating number (MC) on all shipping documents.
- 2. CARRIER shall not RE-BROKER, CO-BROKER, DOUBLE-BROKER, SUBCONTRACT, ASSIGN, INTERLINE, OR TRANSFER THE TRANSPORTATION of shipments hereunder to any other persons or entity conducting business under a different operating authority, without prior written consent of BROKER. If CARRIER breaches this provision, BROKER shall have the right of paying the monies it owes CARRIER directly to the delivering carrier, in lieu of payment to CARRIER. CARRIER will be liable for all losses suffered by the BROKER and its customers.
- 3. Carrier shall be liable for the full value of the transported cargo and any other related costs in case of UNAUTHORIZED BREAKING OF THE SEAL without written consent.
- 4. Carrier shall set the **TEMPERATURE SETTING** to continuous (not on/off) for all reefer loads, unless otherwise directed by Broker or Shipper in writing. Carrier shall comply with all of Broker's and Shipper's instructions as to temperature and transportation requirements, including, but not limited to continuous temperature setting. In the event there is a discrepancy between Broker's and Shipper's instructions (for perishables, food products, produce, or any other cargo), Carrier shall notify Broker immediately and shall not transport the property until Broker has advised Carrier of the appropriate instructions. In the event Carrier fails to comply with the terms of the Section and the cargo is lost, damaged, or otherwise rejected for any reason, Carrier shall be liable for the full value of the load.
- 5. Carrier must immediately contact CAT should any CARGO DAMAGE OR DISCREPANCIES are noted during cargo loading. Any unreported cargo damage or discrepancies shall be presumed to be caused by the Carrier.
- 6. Carrier must immediately contact CAT should any problem occur during transport, including without limitation any delivery delay, accident, overages, shortages and damages.
- 7. Carrier must immediately contact CAT should any cargo damage, discrepancies or consignee remarks written on BOL occurs.
- 8. Carrier hereby waives its right to seek payment of its freight charges from the shipper, the consignee or from any of CAT's customers, and further agrees not to contact said parties for any reason and in any manner whatsoever.
- 9. Carrier must immediately contact CAT should any problem occur during transport, including without limitation any delivery delay, overages, shortages and damages.
- 10. All detention must be reported no later than ninety (90) minutes after arrival, failing which detention costs will not be approved.
- 11. All extra charges must be approved in writing by CAT's representative via a revised load confirmation.
- 12. No payment will be made until proof of delivery of the goods accompanied by the bill of lading and all related and signed documents have been provided to CAT, to its total satisfaction, which documents shall be emailed to CAT within twenty four (24) hours of delivery.
- 13. For a period of two (2) year following the execution of the transport movement, Carrier undertakes not to solicit for transportation, arrange for, or accept, directly or indirectly, loads from CAT's customers, the shipper and the consignee named in this Contract of Carriage.
- 14. Should Carrier fail to sign and return the Contract of Carriage to CAT prior to the execution of the transport movement, Carrier agrees and covenants that by taking possession of the entrusted goods, it will be bound by the terms and conditions of this Contract of Carriage.
- 15. In case of discrepancies between this Contract of Carriage and the bill of lading to be issued by the Carrier, the terms and conditions of this Contract of Carriage shall prevail.
- 16. This Contract of Carriage will also be subject to the Motor Transportation Agreement entered into between CAT and the Carrier. In case of discrepancies between this Contract of Carriage and the Transportation Agreement, the latter will prevail.
- 17. This Contract of Carriage shall be governed by the laws and regulations of the Province of Quebec.
