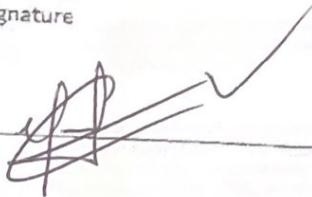

**Purpose of Form**
