### Purpose of Form

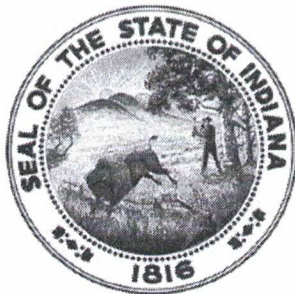

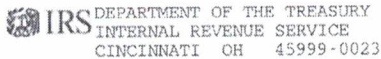
