


Moreover, this signed Release may be pleaded by COMPANY as a counter claim to or as a defense in bar or abatement of any action of any kind whatsoever brought, instituted, or taken by on behalf of Driver. Driver also agrees that this Release shall be governed by the laws of (State).
- Passenger's (or Passenger's parent's or guardian's) full release of liability - In consideration for COMPANY's authorization to allow Passenger to ride in the equipment, Passenger, or Passenger's parent or guardian if Passenger is under the age of 18, by signing below, hereby releases COMPANY, with respect to the authorized transportation, from any and all claims, liability, rights, actions, suits, and demands, COMPANY, including its affiliates, employees, agents, officers, directors, or successors. Moreover, this signed Release may be pleaded by COMPANY as a counter claim to or as a defense in bar or abatement of any action of any kind whatsoever brought, instituted, or taken by or on behalf of Passenger. Passenger also agrees that this Release shall be governed by the laws of (State).
