STARTED CHECKING THE CONNECTIONS AT THE BATTERY AND ON THE FRAME. ALL WERE TIGHT. CHECKED ON THE POWER WIRES AT THE PASS THROUGH AND ABOVE THE THROTTLE PEDAL BUT ALL WERE TIGHT. CHECKED THE BATTERIES AND ALL TESTED GOOD. THEN CHECKED THE CONNECTION AT THE ELECTRIC BATTERY SHUT OFF BOX AND FOUND THAT ONE OF THE TERMINALS WAS LOOSE ON THE INTERNAL SIDE OF THE BOX. I REMOVED THE POWER CABLES FROM THE BOX AND REMOVED THE BOX. NEXT I INSTALLED A NEW BATTERY SHUT OF BOX AND SECURED THE CABLES WITH WIRE TIES. THEN CLEARED ALL DTC'S AND TRUCK WAS TEST DROVE TO SEE IF ANY CODES RETURNED.
